BART Police Civilian Review Board Meeting Minutes Monday, October 20, 2025

A regular meeting of the BART Police Civilian Review Board (BPCRB) was held on **October 20, 2025**, convening at 4:02 p.m. in the BART Board Room, 2150 Webster Street, 1st Floor, Oakland, California 94612.

The meeting was called to order by Chairperson Dana Lang; and Mag Tatum, Recording Secretary.

Chairperson Dana Lang gave instructions on the in-person meeting, with an option for public participation via teleconference, accessing the presentation materials online, Public comments, and Members' remarks.

1. Call to Order.

The regular meeting was convened at 4:02 p.m. by Chairperson Dana Lang.

*Excerpt of Policy 302 Use of Force, Page 2:

Minimal amount of force necessary - The lowest level of force within the range of objectively reasonable force that is necessary to effect an arrest or achieve a lawful objective without increasing the risk to others. Officers may only use the level of force they reasonably believe is proportional to the seriousness of the suspected offense or the reasonably perceived level of actual or threatened resistance.

Necessary – No reasonably effective alternative to the use of force appeared at the time and the amount of force used was reasonable based on the Department's policy and training to effect the lawful purpose intended.

8. Discussion on the BART Police Department's Progressive Policing and Community Engagement Bureau (PPCEB) regarding Housing Opportunities for the Winter Months (Member Mensinger's Request) (Verbal Report Only).

Chief of Police Kevin Franklin and Natalie Robinson, Supervisor of Crisis Intervention & Outreach Programs, presented information before the Board, regarding PPCEB Housing Opportunities for the Winter Months. The item was discussed.
