

INVOICING



NO NEW INVOICES ON HOLD!

Route for Payment (Complete or Minor Corrections)

- Invoice package is substantially correct
- Minor corrections of typos, rounding errors, etc.
- Miscalculations that don't impact balance due

Short-Pay (only applicable for ODC)

- Invoice package is substantially correct
- Short-Pay will not have material impact on future invoices

Reject (Materially Incomplete/Incorrect)

- Missing supporting documents/approvals (work at risk, rates, timesheets, overtime)
- Budget deviation (overspending line items, etc.)
- Missing progress reports

Specialty Support / Technical Expertise

Work Plans for specialized engineering expertise assigned to projects, do not require extensive programmatic oversight or administrative support.



Yes:

- 1. Non-discretionary rotation.
- 2. Even distribution among agreements.
- 3. Specific (rare) technical expertise.

No:

- 1. Mini-competitions
- 2. PM-based selection



Work Plan Updates

SAME SCOPE, NEW WORK PLAN

- (YES) TRANSITIONAL WORK PLANS Portion of original work plan scope, for a limited duration and fraction of budget, to bring project to a natural stopping point
- (NO) CONTINUATIONS Original work plan scope and/or expanded scope carried forward across numerous work plans

STAFFING CHANGES

- PM approval/notification required
- Key Personnel changes must be in writing to Agreement Manager for approval

ON-SITE STAFF

 Contractors must work on site as needed per project

Budget Revisions v. Work Plan Modification

Budget Revision = Movement of budget between line items

- Prime Labor → Subconsultant Labor
- Subconsultant Labor \rightarrow Prime Labor
- ODC → Any Labor
- No Change to Prime Fixed Fee

Do it BEFORE invoicing it!

Work Plan Modification

- Change in Scope New Work Plan
- Work Plan Schedule Extension Let Us Know
- Removal Scope Decommitment of Funding
