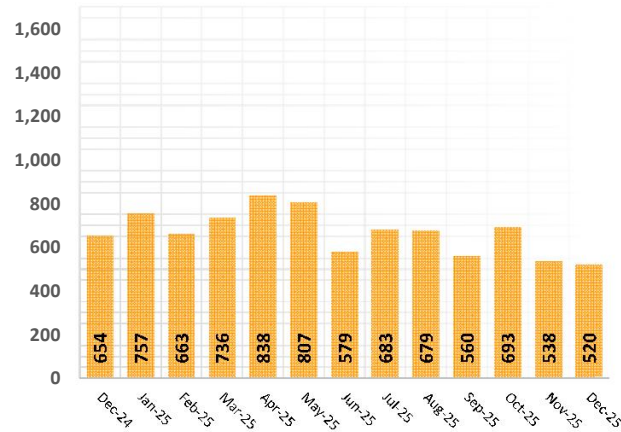


## PRIORITY TYPE 1 - 3 CALLS



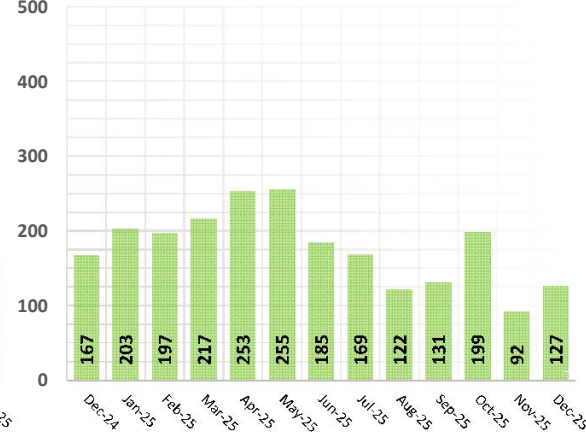
## FARE EVASION CAD CALLS

Dispatch Fare Evasion Calls



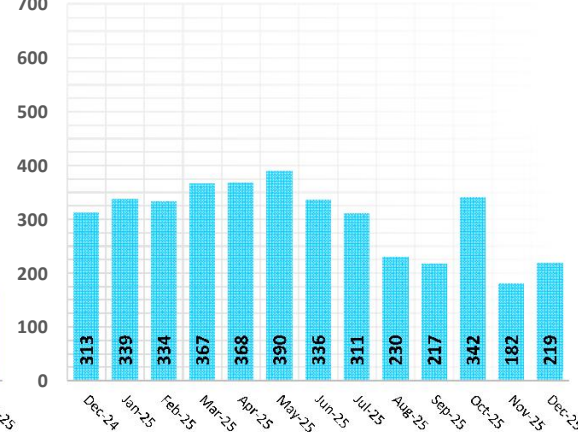
## FARE EVASION CITATIONS

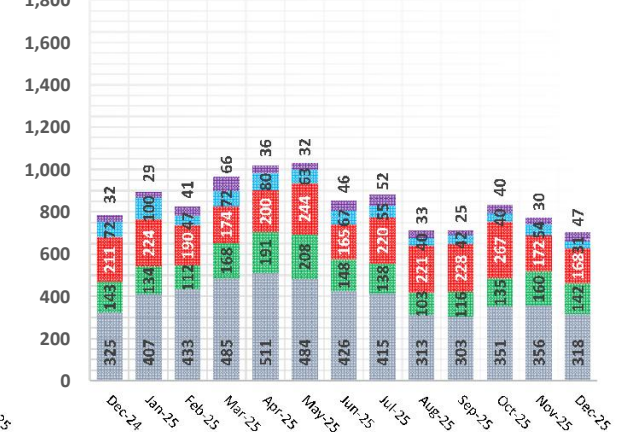

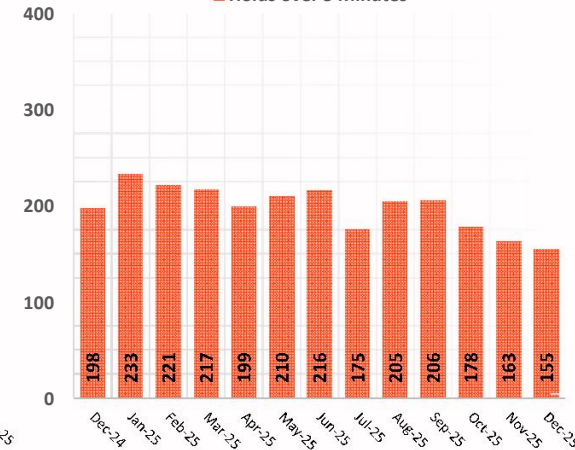

Emergency Response (Minutes)



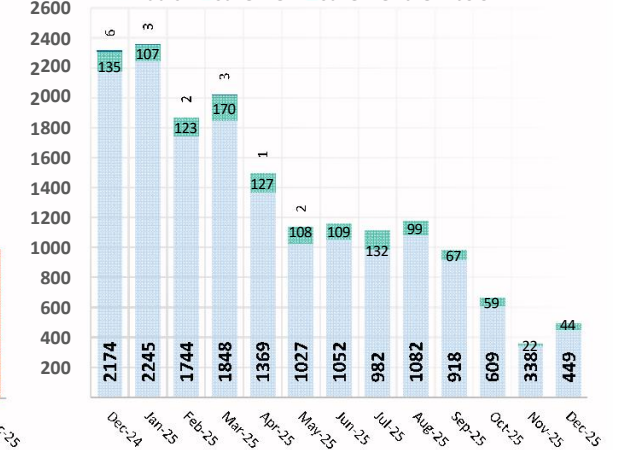

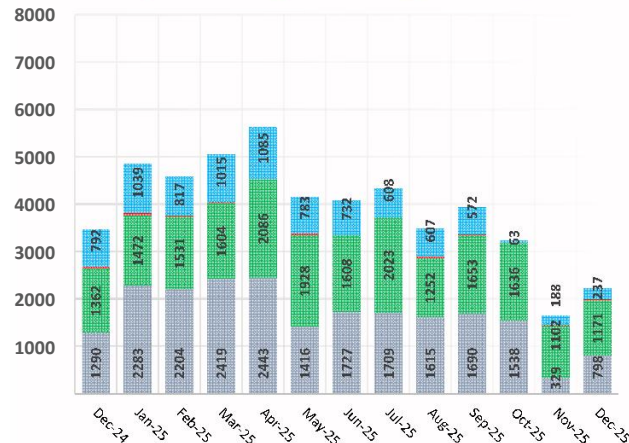

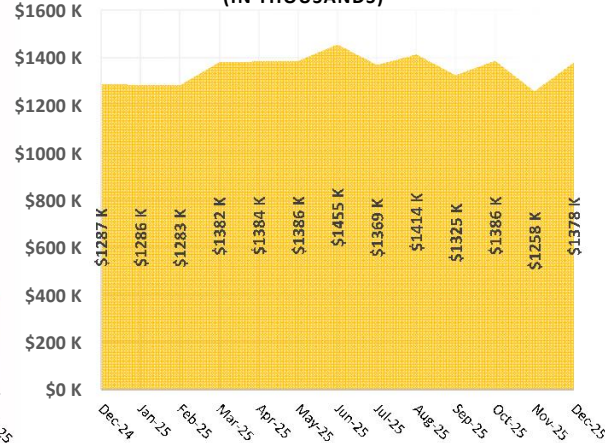

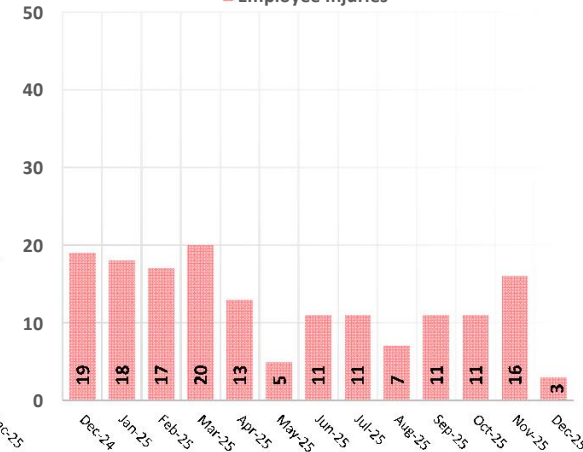

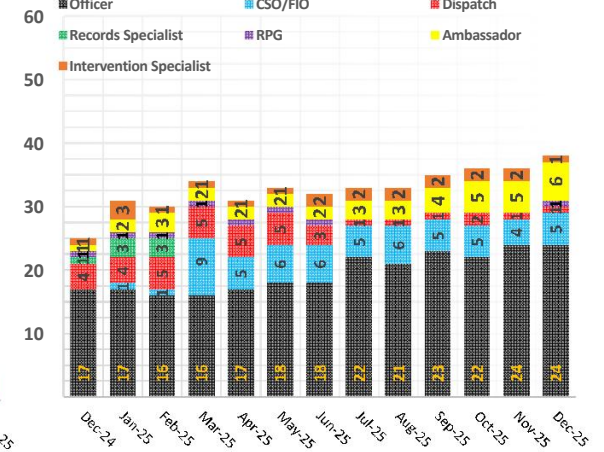

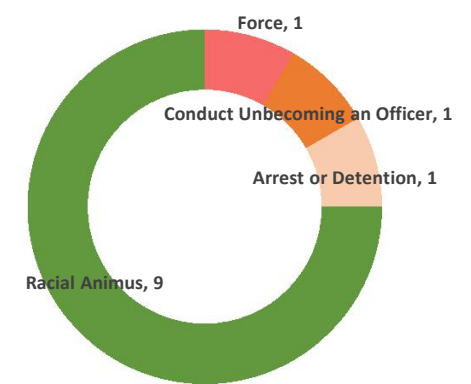

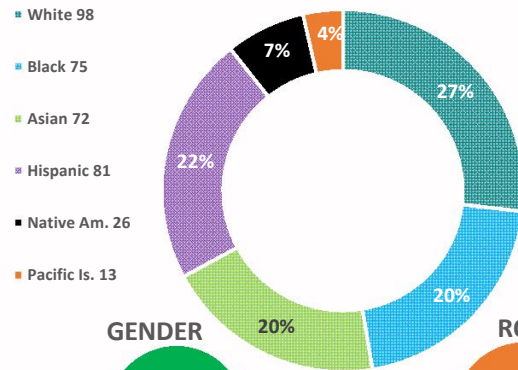


## IA COMPLAINTS RECEIVED<sup>1</sup>

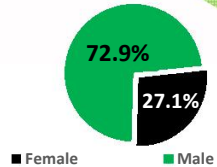

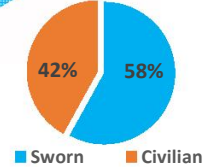

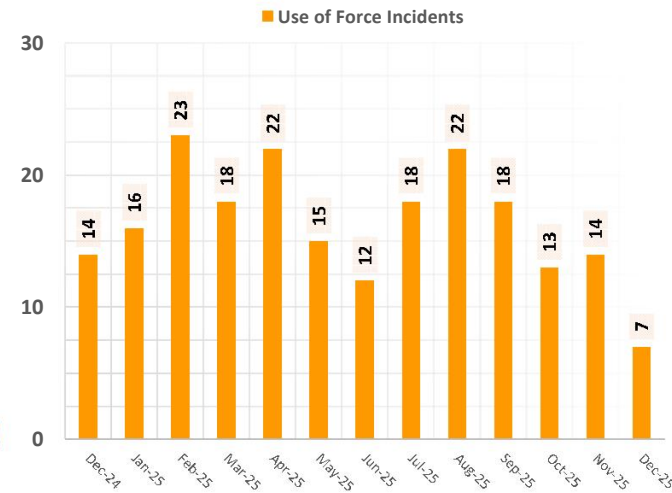

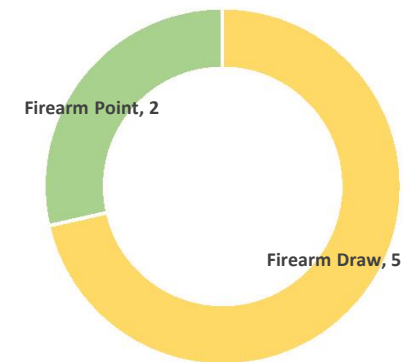

## USE OF FORCE INCIDENTS

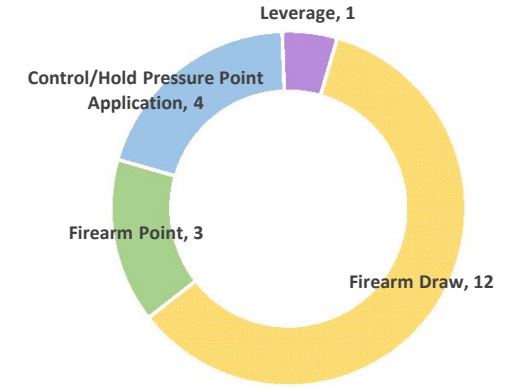


## INCIDENT FORCE OPTIONS USED<sup>2</sup>
