Change Order to 34.5 kV Cable Replacement and Fiber Optic Cable Installation, A-Line

PURPOSE:

To obtain Board authorization for the General Manager to negotiate and execute Change Order(s) to Contract No. 15EJ-180, 34.5kV Cable Replacement and Fiber Optic Cable Installation, A-Line, DMZ Builders, in an amount not to exceed \$8,000,000.00 for replacement of traction power cables and associated infrastructure.

DISCUSSION:

A recent fire caused significant damage to traction power cables at the San Leandro Station which, in turn, caused significant disruptions and impacts to revenue service throughout the system. Through this action, the General Manager would be authorized to swiftly implement work to remove and replace traction power cables and associated infrastructure impacted by the fire

Contract 15EJ-180 already includes scope to install traction power cables and associated infrastructure on the A-Line. This Change Order work would include, but would not be limited to, demolition of damaged cabling infrastructure, installation of replacement cables, and relocation/replacement of associated infrastructure.

CAPITAL FISCAL IMPACT:

The \$8,000,000 authorization to execute this Change Order to Contract No. 15EJ-180 contributes to Fiscal Year 2025 - System Reinvestment expenditure amount of

\$250,513,587.
