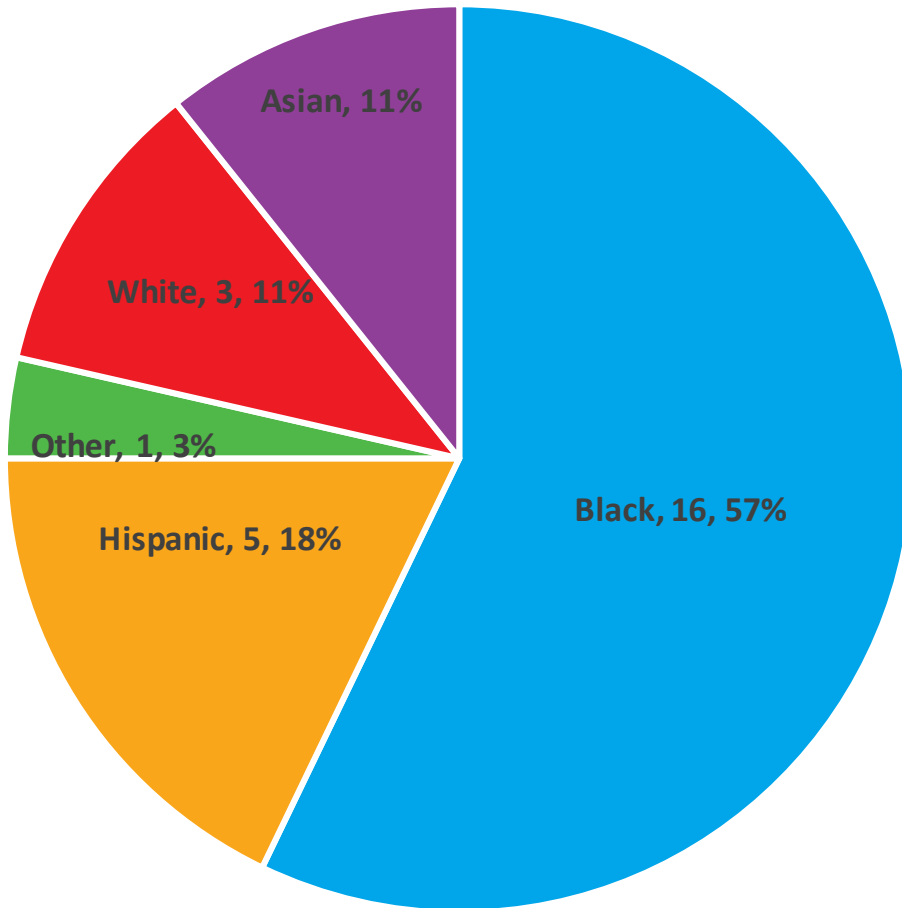

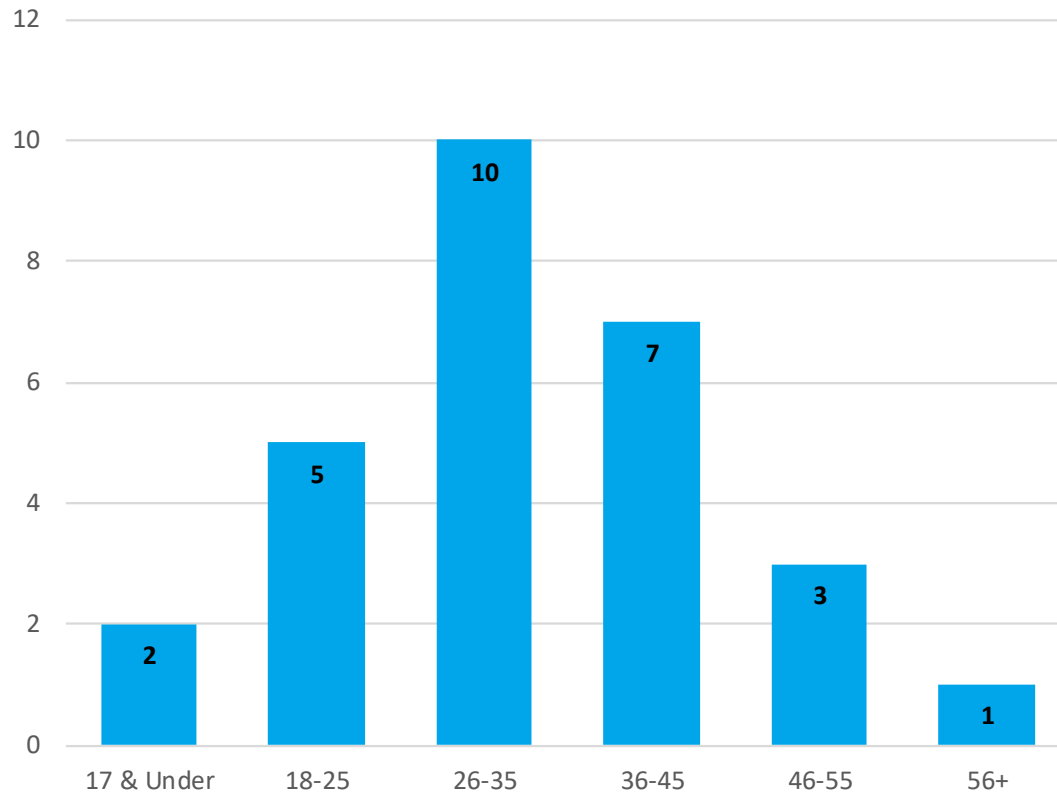

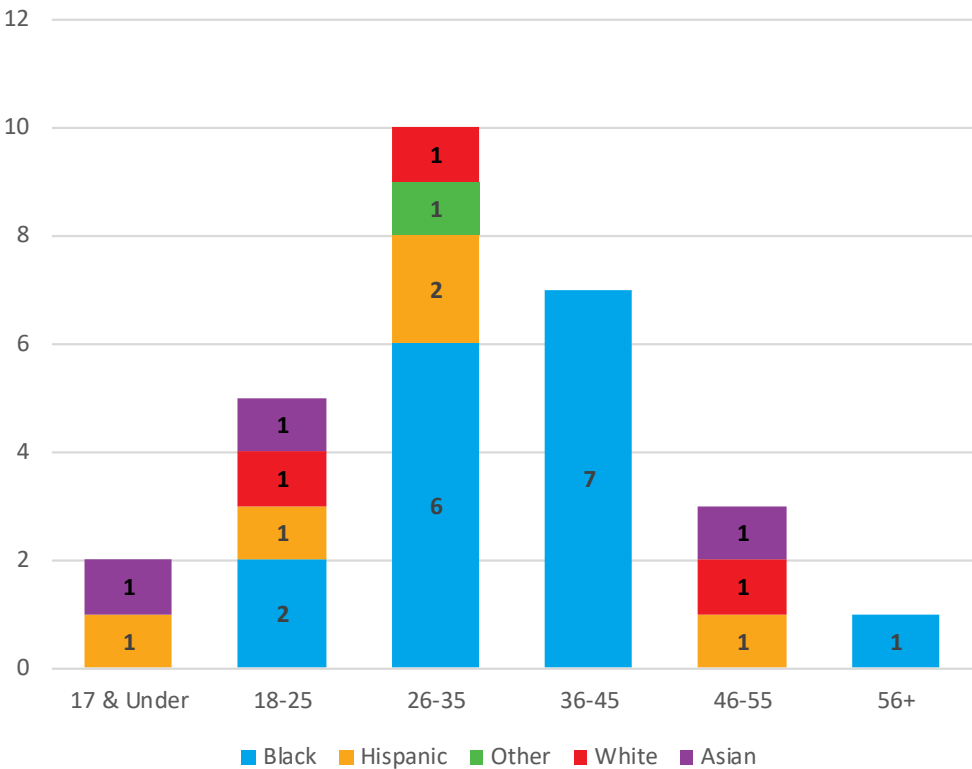

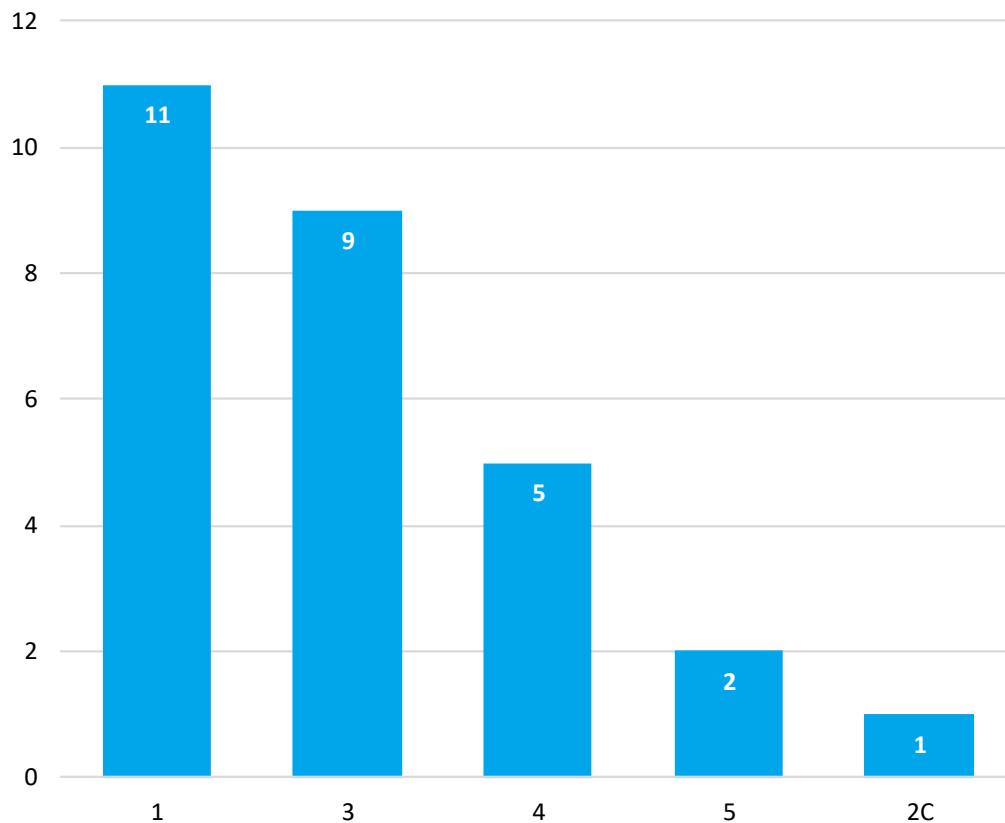

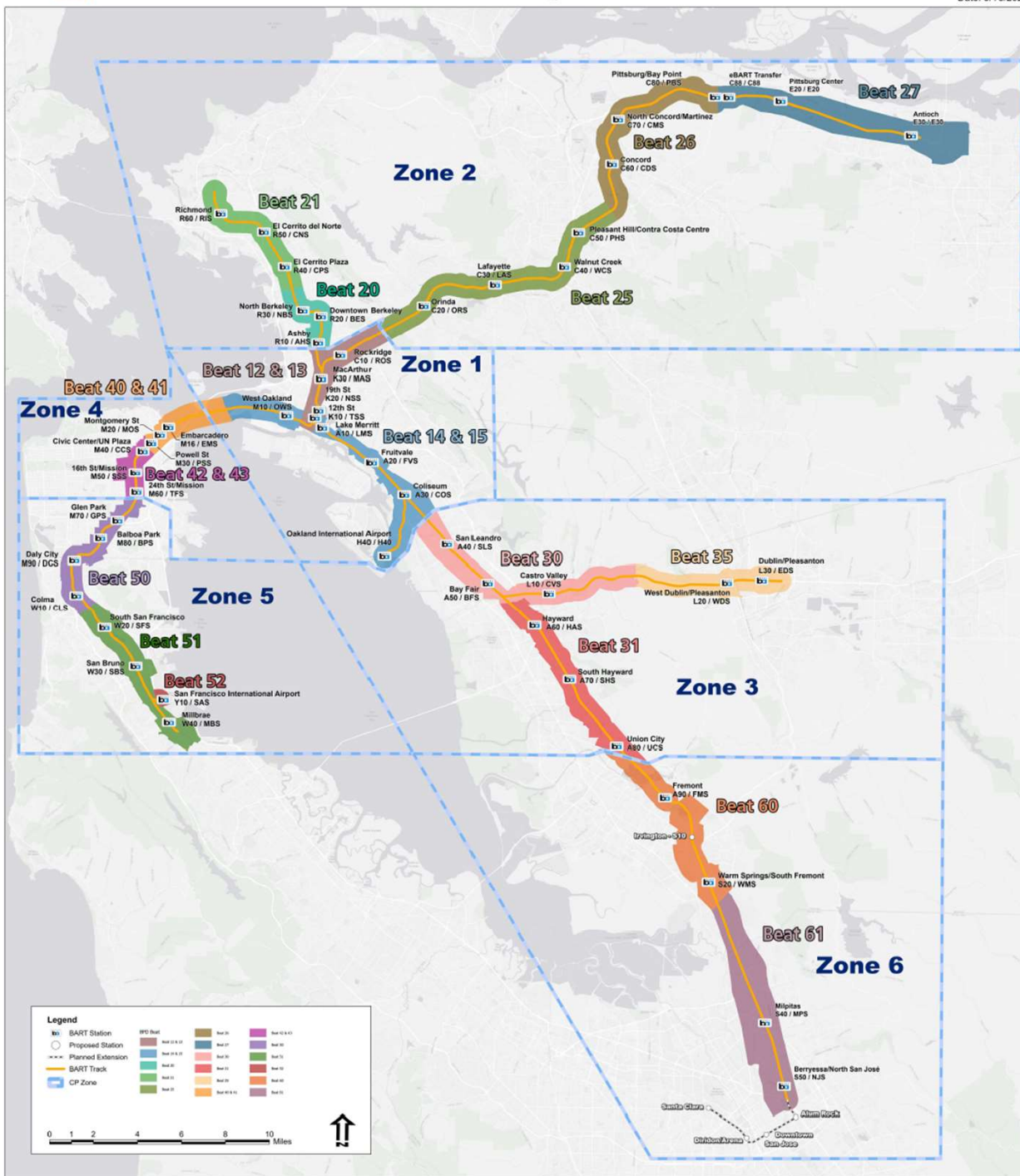

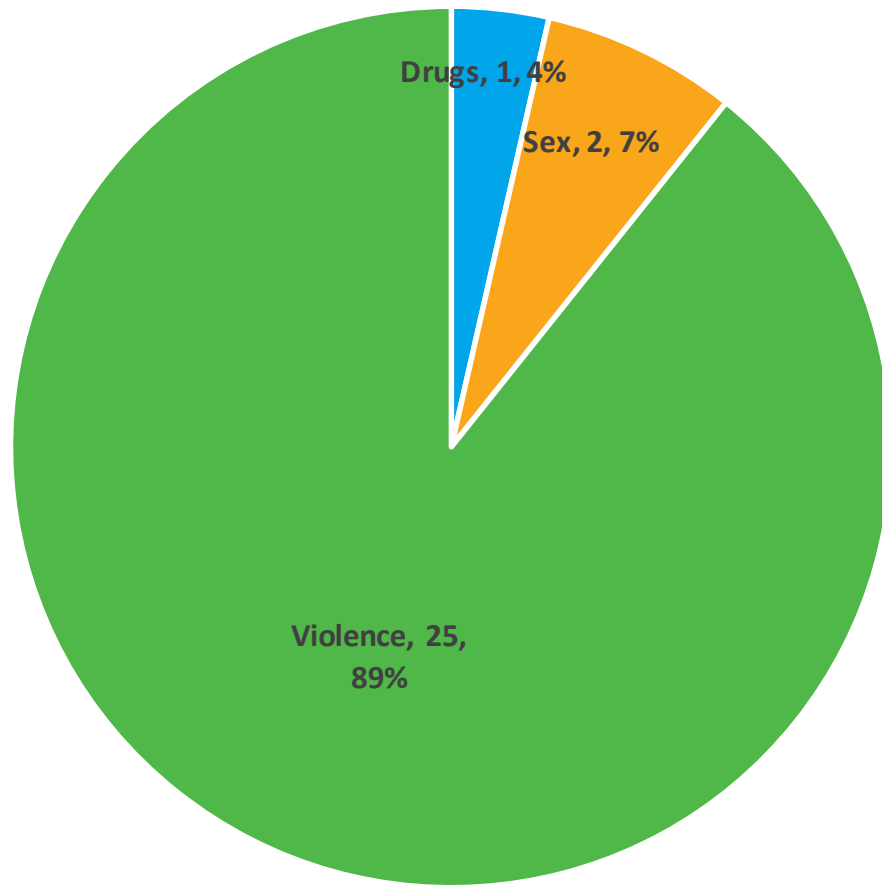

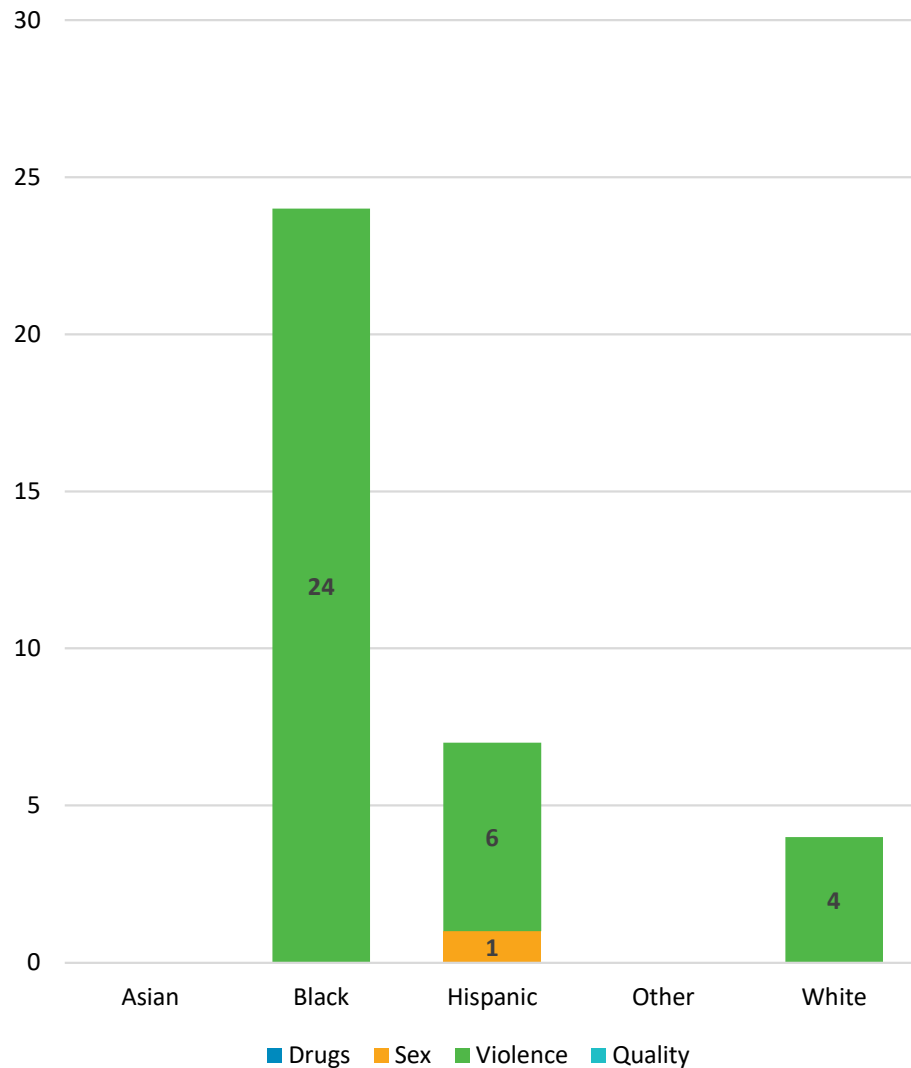

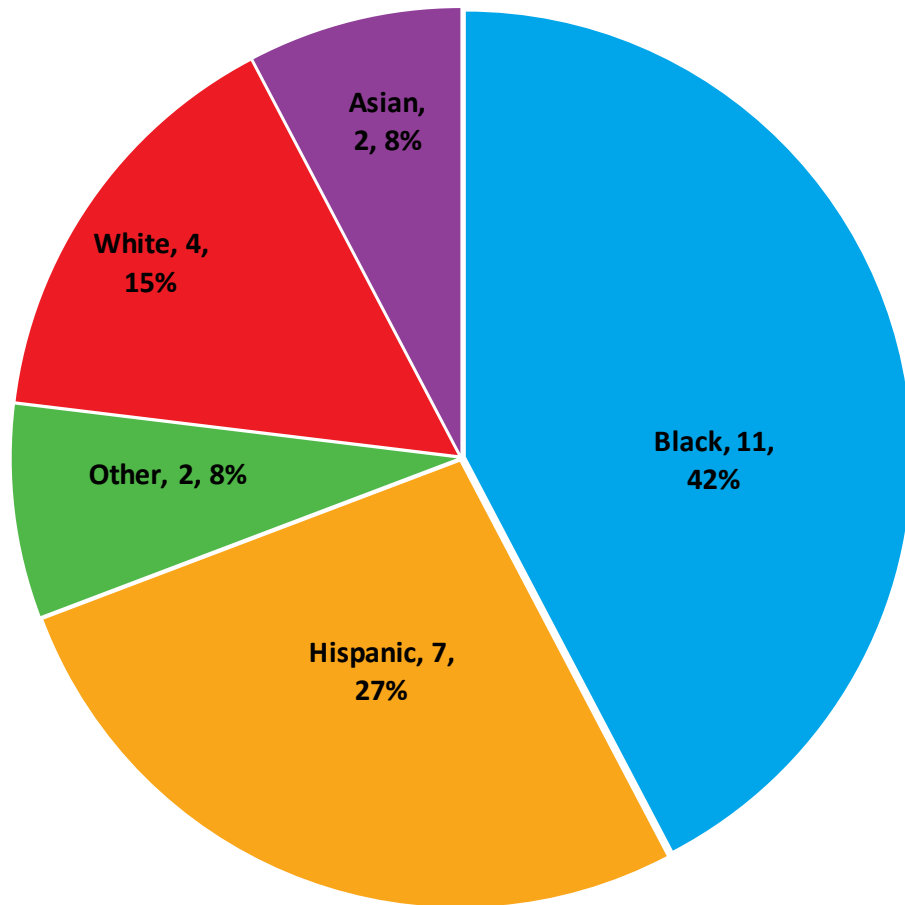

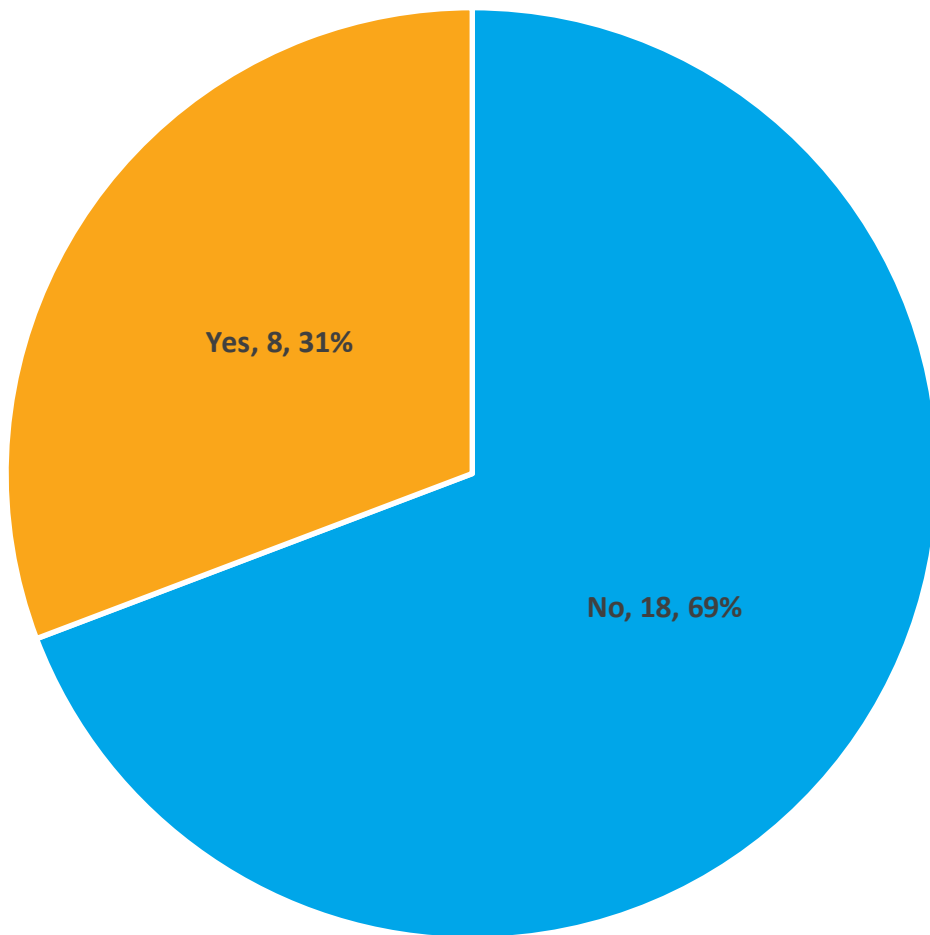

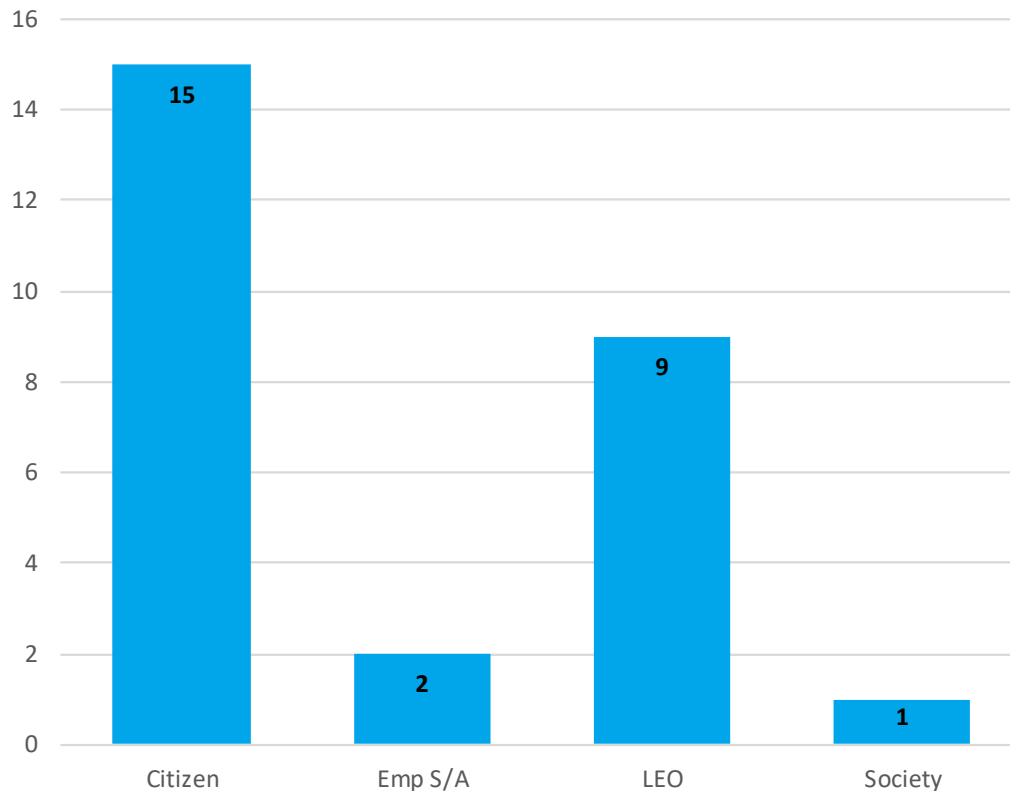

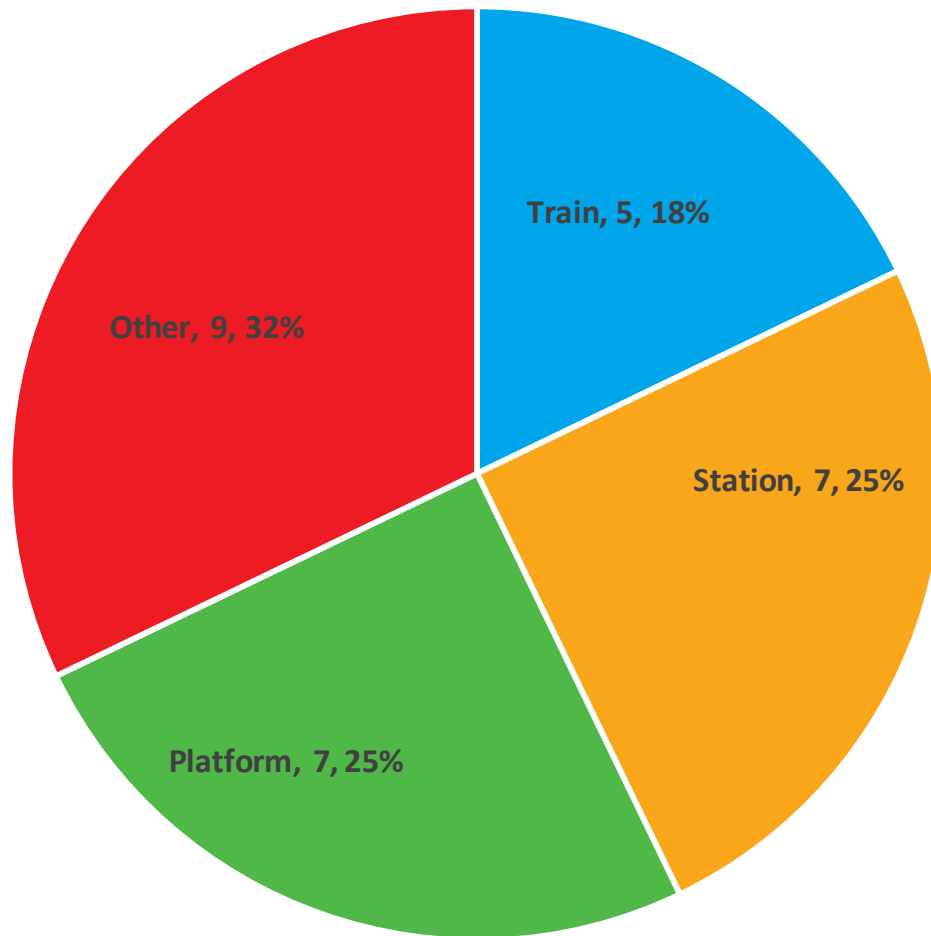

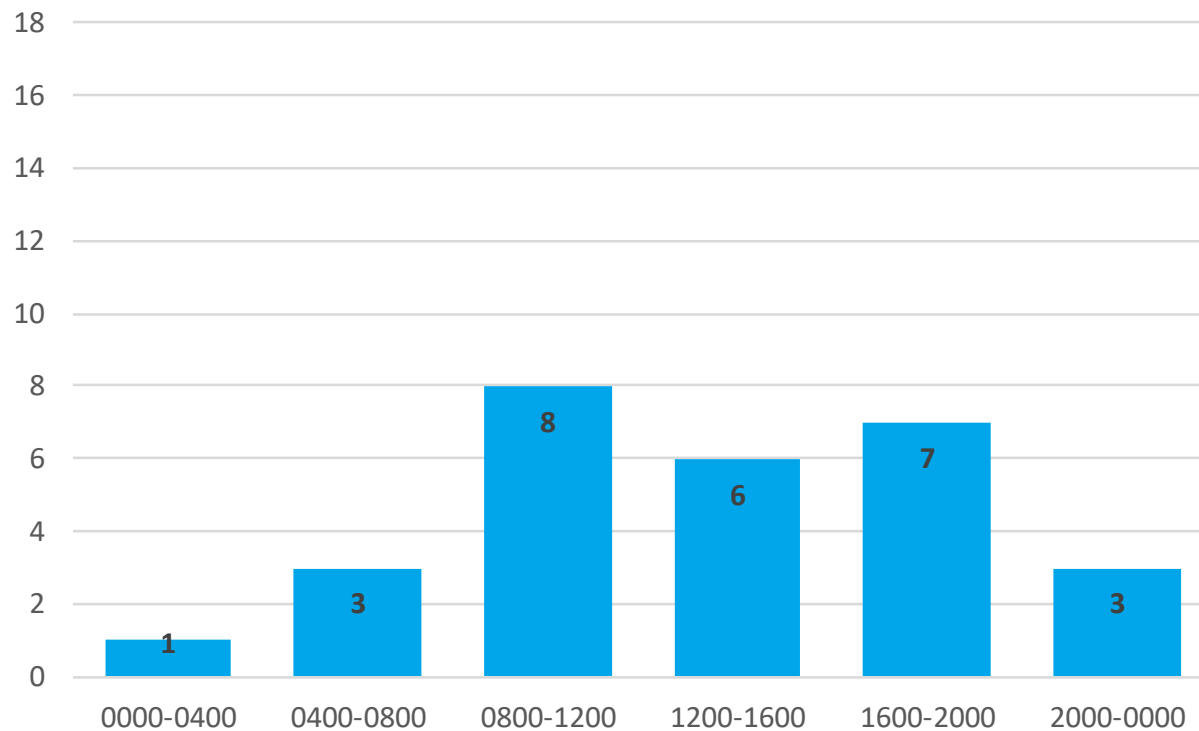


Prohibition Orders by Location
