Amendments from April 29

- Remove language relating to the Transit Operations Financial Responsibility and Implementation Plan (T-FRIP).
- Clarify that provisions of the bill only apply to counties identified in the Transportation Revenue Measure District.
- Require the Metropolitan Transportation Commission (MTC) to submit a report to the Legislature by March 31, 2026, that projects the impact to ridership on AC Transit, BART, Caltrain, and Muni from planned transportation projects and strategies outlined in MTC's regional transportation plan, with attention to rail connectivity projects that could increase ridership, reduce operating costs, or enhance mobility.
- Add a legislative finding and declaration that “the San Francisco Bay Area also needs to prioritize increasing ridership to ensure the region’s transit network is sustainable.”

Fair-Share Scenario Discussions

- Conversations are ongoing between operators, county transportation authorities, and bill authors regarding methods to attribute major operator costs by county.
- Still awaiting final report from MTC's third-party independent financial review of operators to inform regional measure discussions.

Next Steps

- Bill referred to the Senate Appropriations Committee for an initial hearing in the coming weeks.
- If placed on the Suspense File, bill will be heard at a special Suspense File hearing on May 23.
- If passed through Appropriations, the bill will move to the Senate Floor, where it must pass by June 6.
