SUBJECT: Policy Updates for BPCRB review

The Policy Review Committee met and approved the following policy for department review and acceptance. Please provide the necessary notification to the BPCRB at your convenience. The modifications to the policies are included below:

Policy 220 Retiree Concealed Firearms – Legislative update CA AB 160 to include requirements for retired peace officers seeking endorsement.

Policy 402 Bias-Based Policing – CALEA update to include refresher civilian training. **Policy 900 Temporary Custody of Adults** – Legislative update CA AB 1269, requiring next of kin notification.

Policy 1000 Recruitment and Selection – Legislative update CA AB 160 to include mandates for completing fingerprint-based state and national criminal history background check.

Policy 220 Retiree Concealed Firearms

October 2025

This policy has been updated because legislative action impacts its content. The update should be accepted and implemented as soon as possible. 2025 CA AB 160 amended the law to allow agencies to require retiring or retired peace officers, who are seeking an endorsement on their identification certificate authorizing them to carry a concealed firearm, to undergo a fingerprint-based state and national criminal history background check. Changes to this policy include:

 In MAINTAINING A CALIFORNIA IDENTIFICATION CARD CCW ENDORSEMENT, content has been updated to include the additional requirement, and a serial comma has been added.

Policy 900 Temporary Custody of Adults

October 2025

This policy has been updated because legislative action impacts its content. The update should be accepted and implemented as soon as possible. 2025 CA AB 1269 enacted Wakiesha's Law which requires a county or city jail to notify all people covered by the medical release of information and next of kin forms of a person in custody within 24 hours of the death of a person incarcerated in a county or city jail. Changes include:

• In **SUICIDE ATTEMPT, DEATH, OR SERIOUS INJURY**, content has been updated to address the new requirements.

Policy 1000 Recruitment and Selection

October 2025

This policy has been updated because legislative action impacts its content. The update should be accepted and implemented as soon as possible. 2025 CA AB 160 mandates that criminal justice and law enforcement agencies must require peace officers, prospective peace officers, employees, and prospective employees to complete a fingerprint-based state and national criminal history background check. The fingerprints, along with other relevant information, must be submitted to the California Department of Justice. Changes to this policy include:

• In **SELECTION PROCESS** and **STANDARDS FOR OFFICERS**, citations have been added. The subsection name is based on a text entity and may vary depending on how you answered the General Information Questionnaire.
