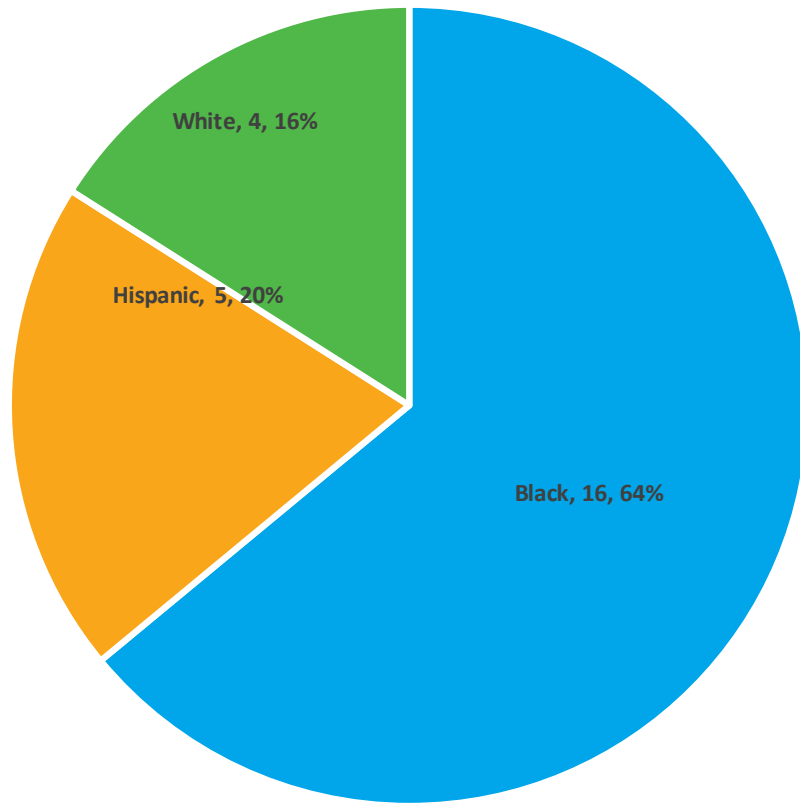

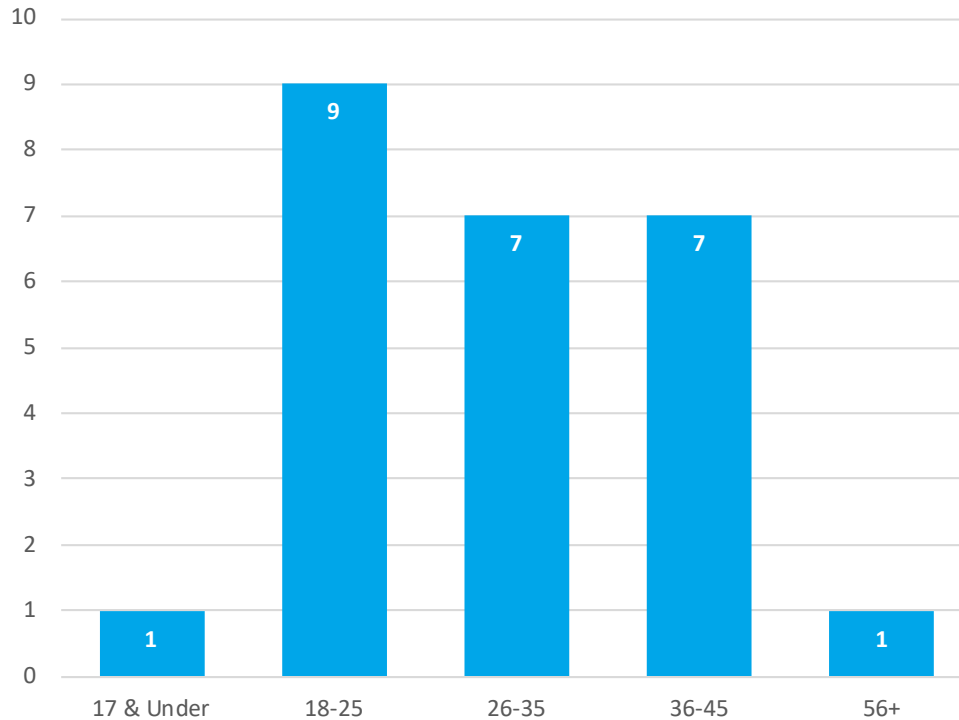

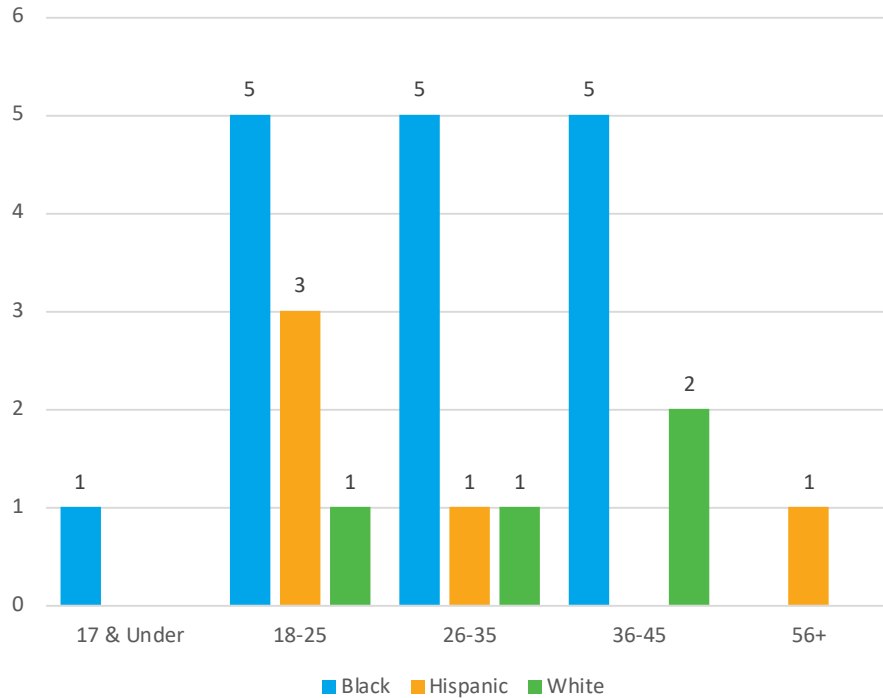

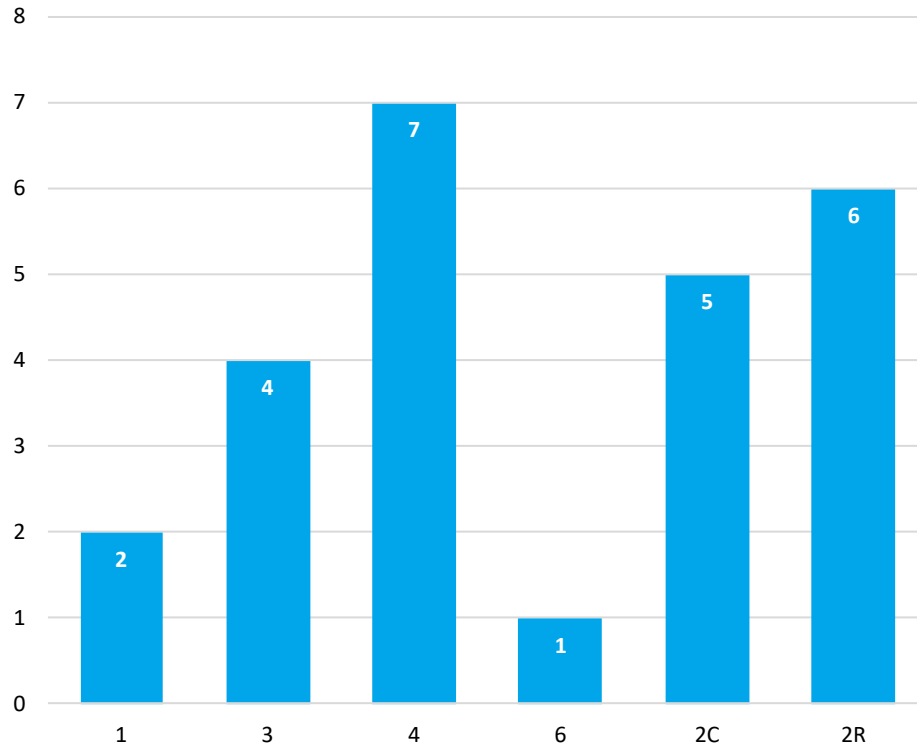

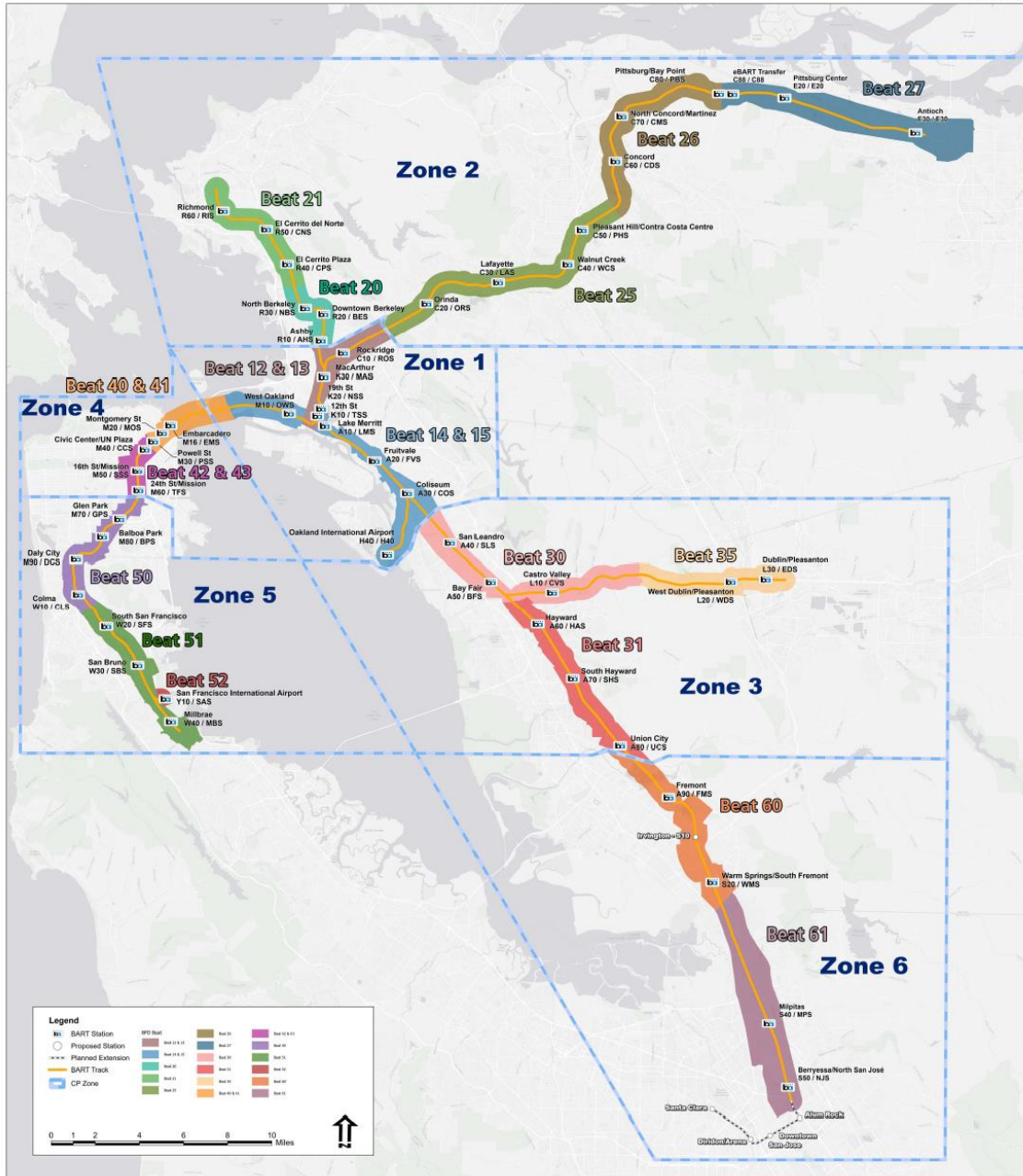

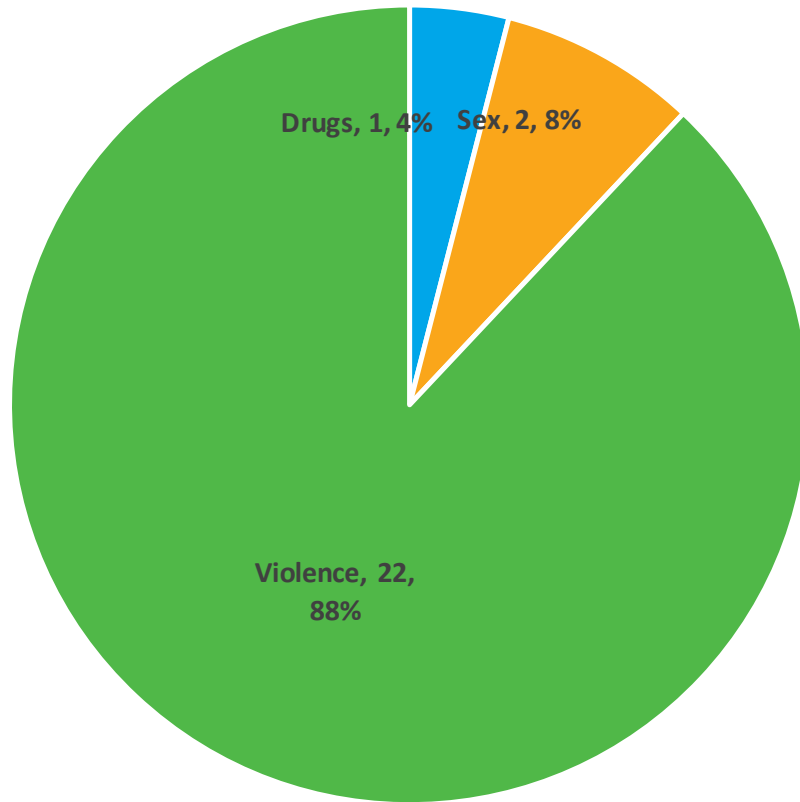


# BART Police Zone Map

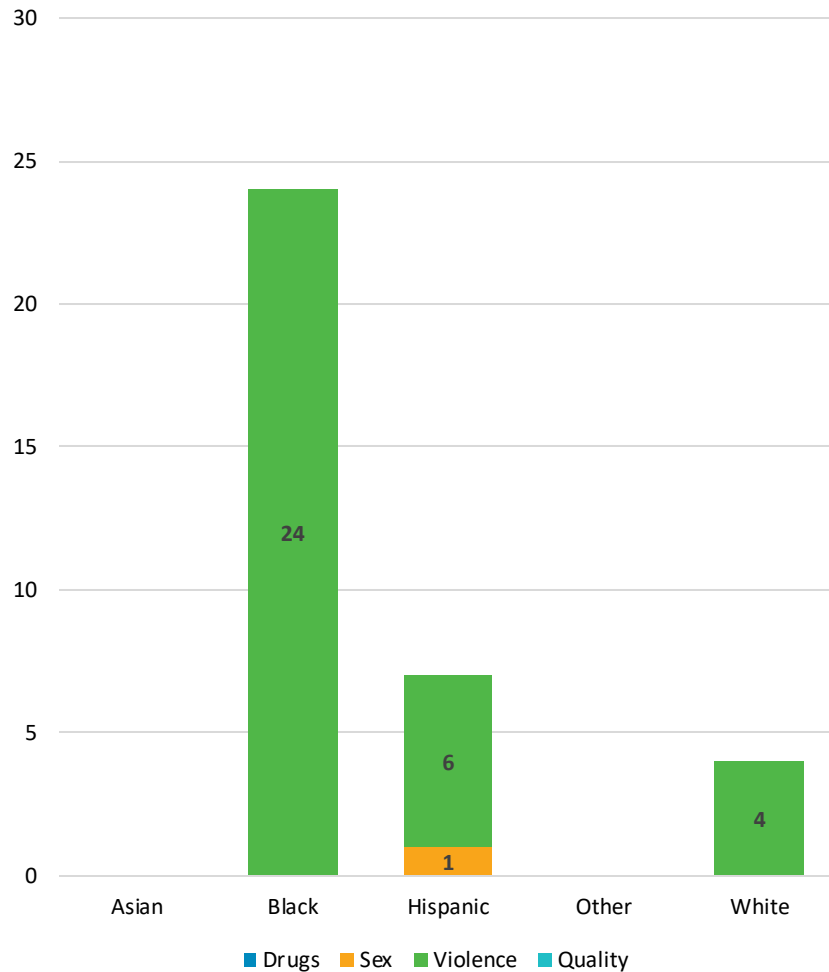
