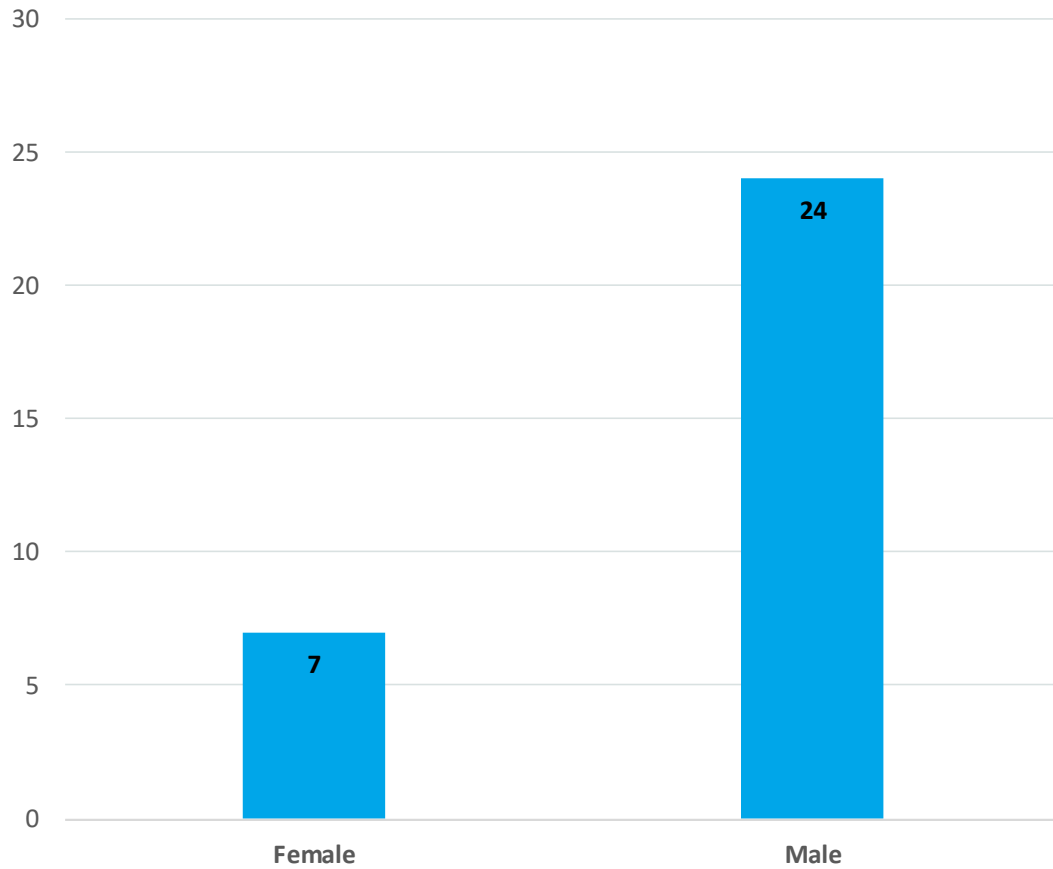

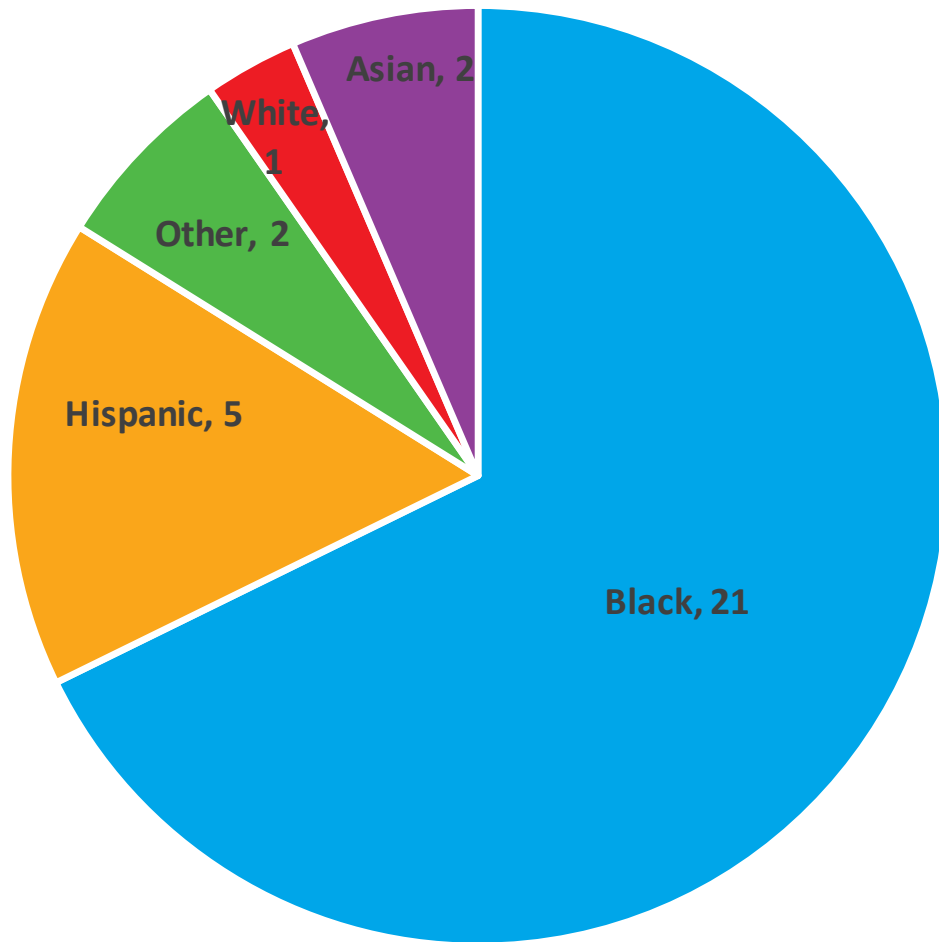

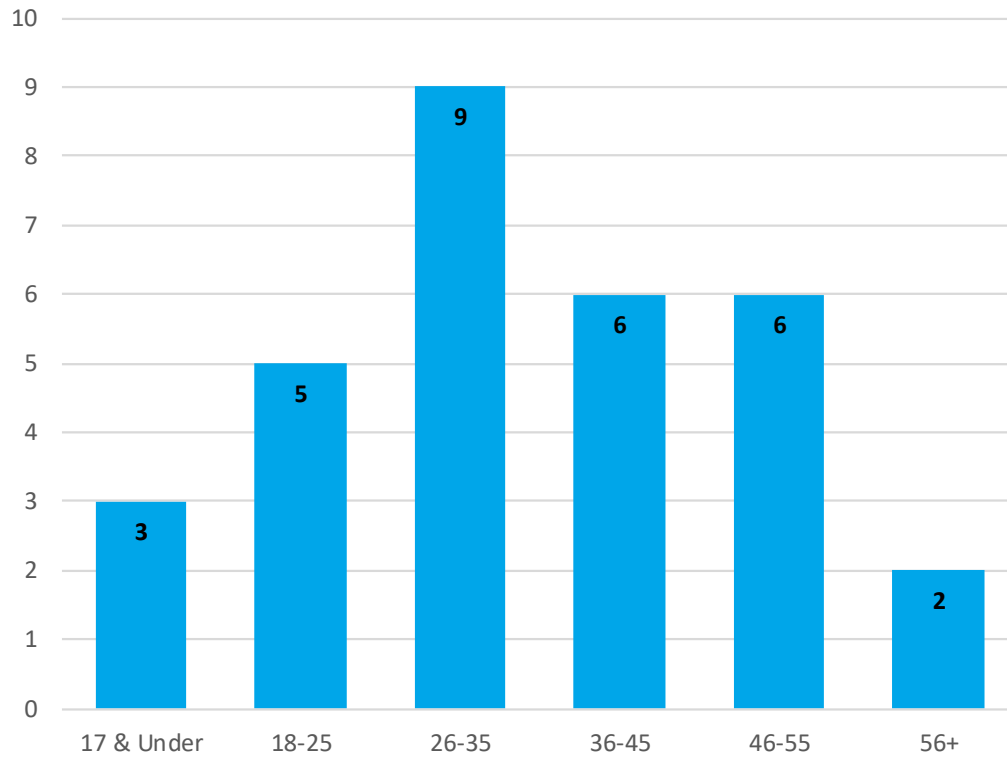

Prohibition Orders Issued by Race



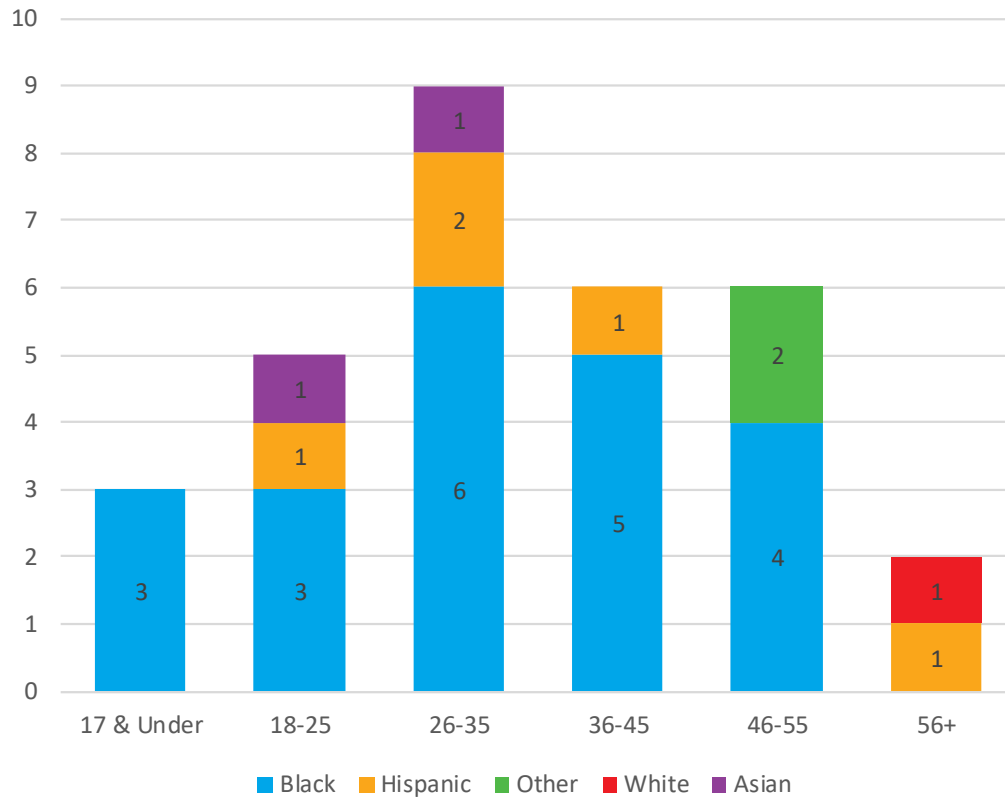

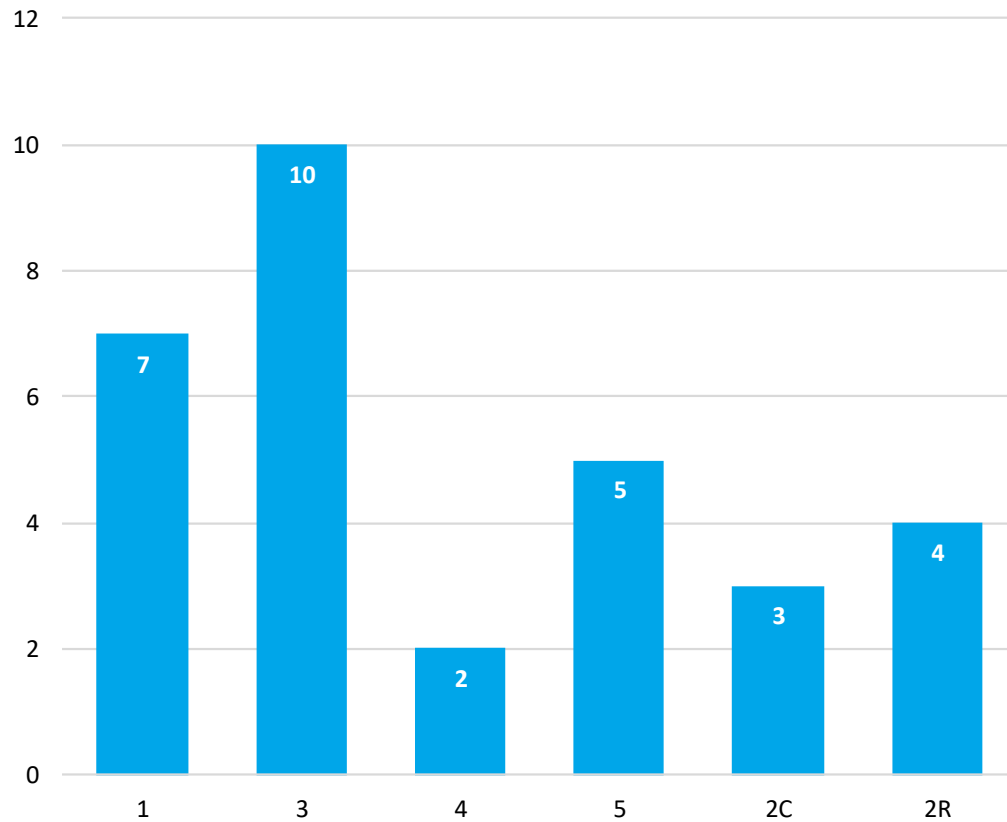

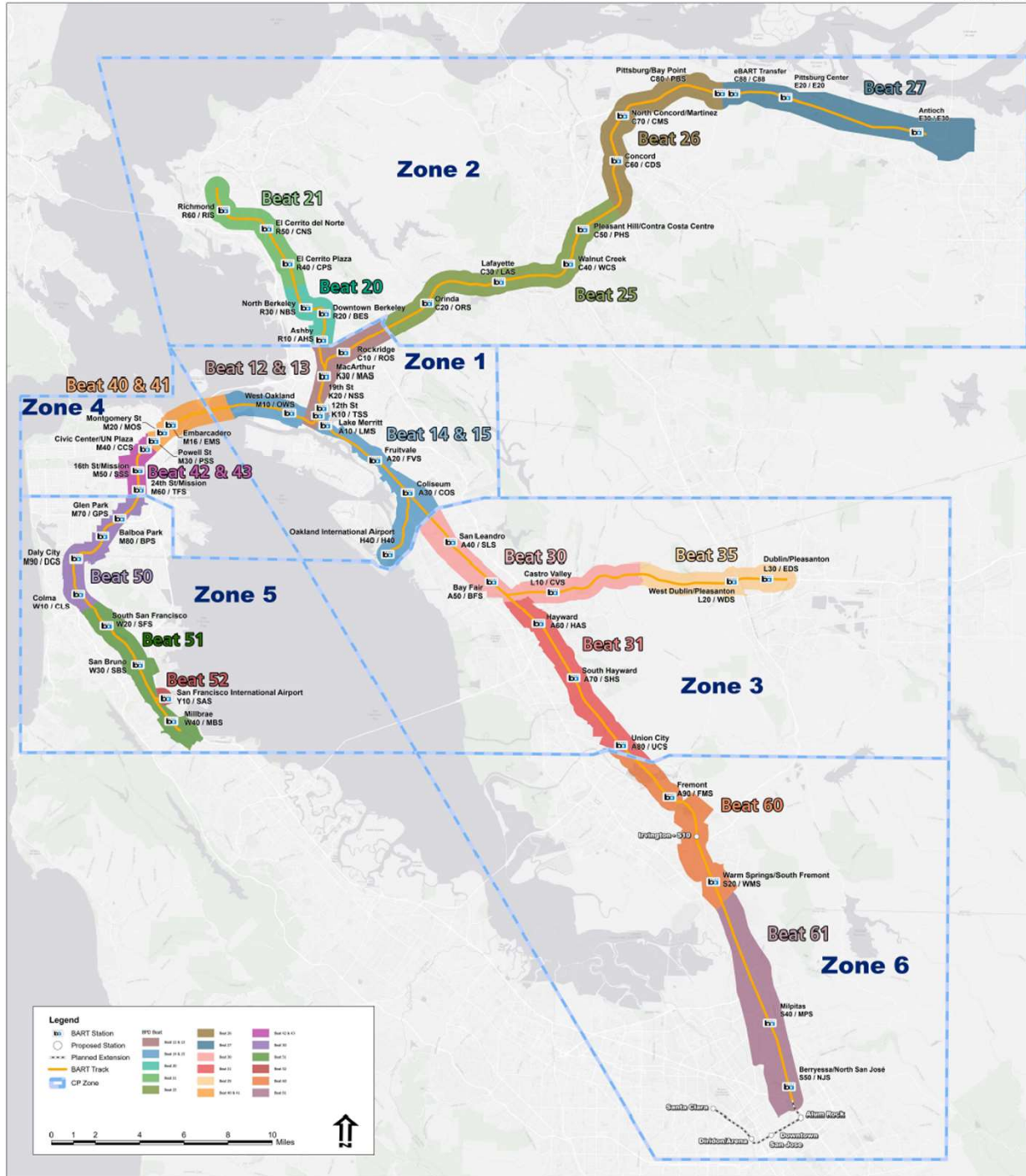

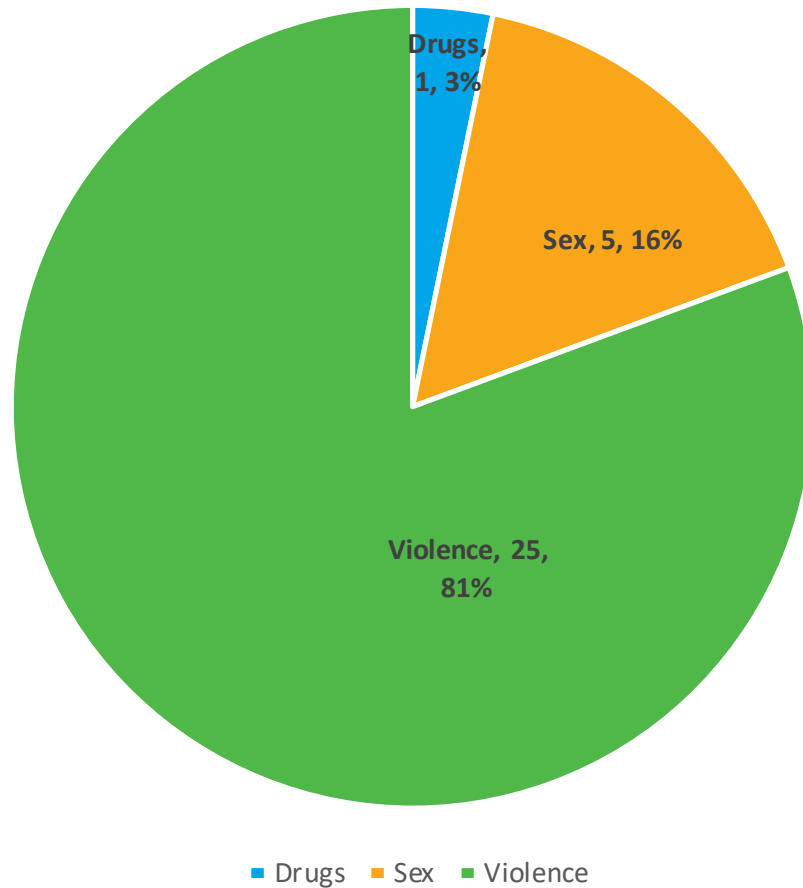

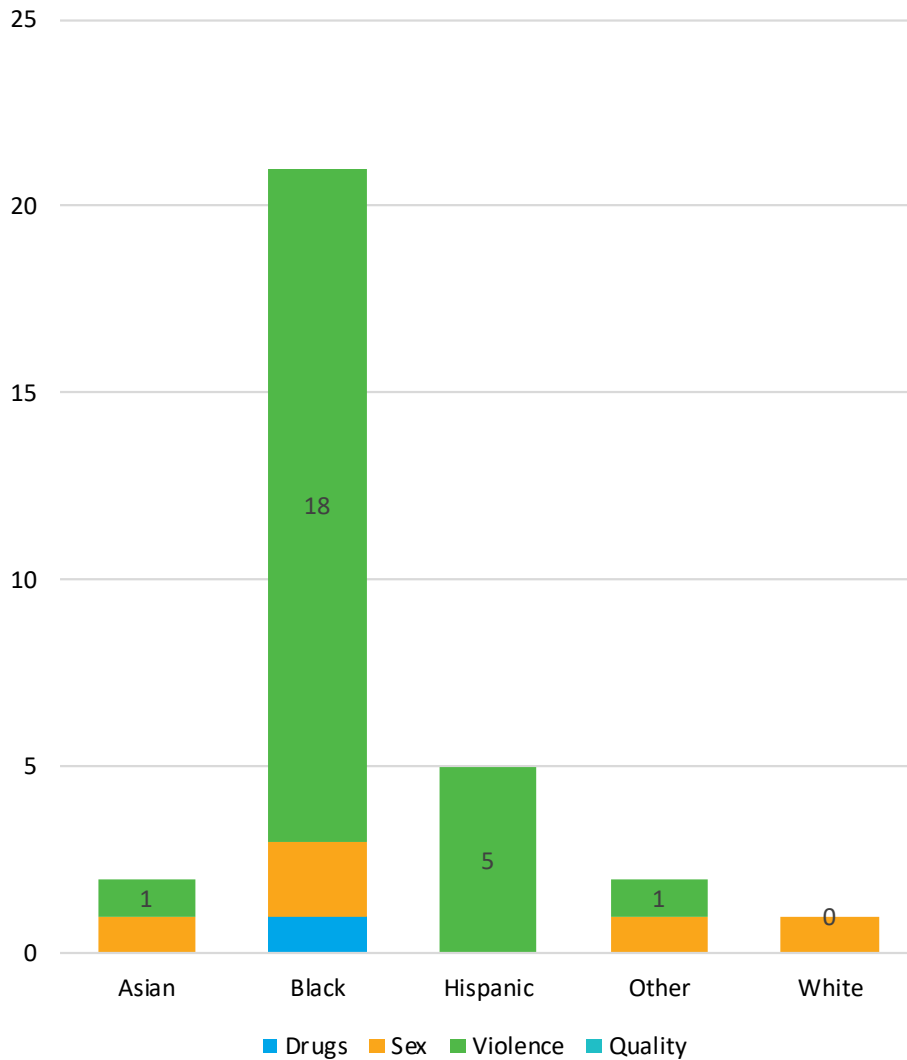


Prohibition Orders by Crime Type



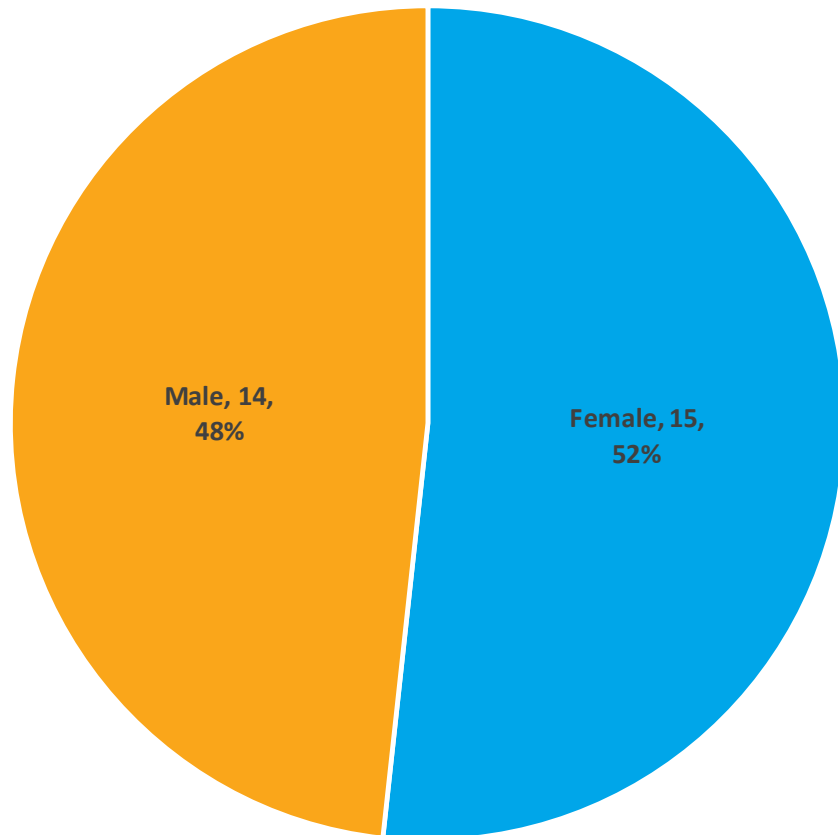

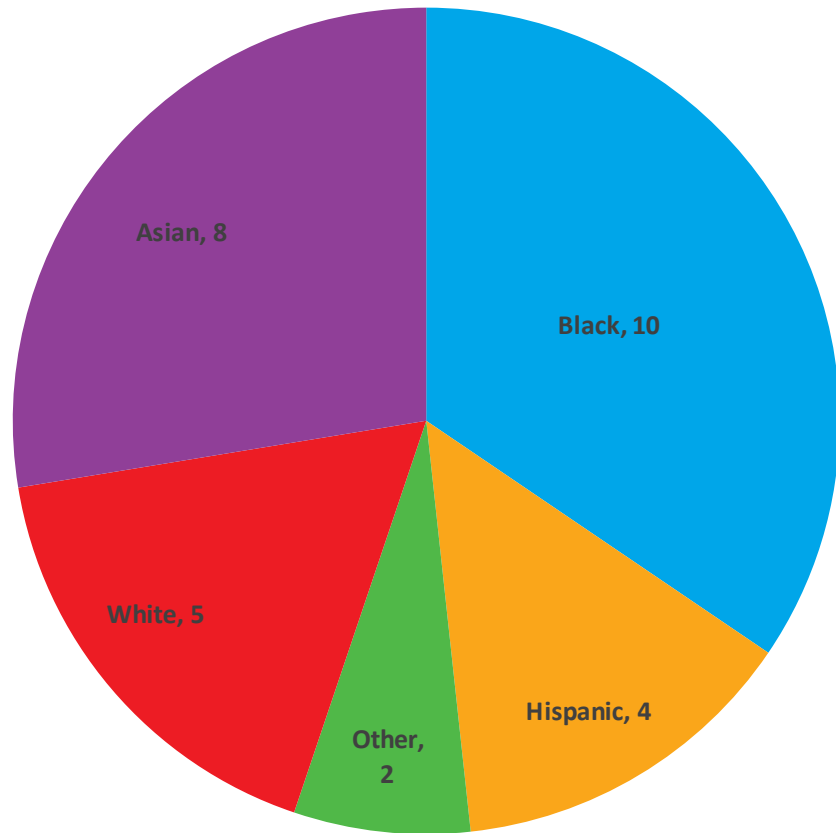

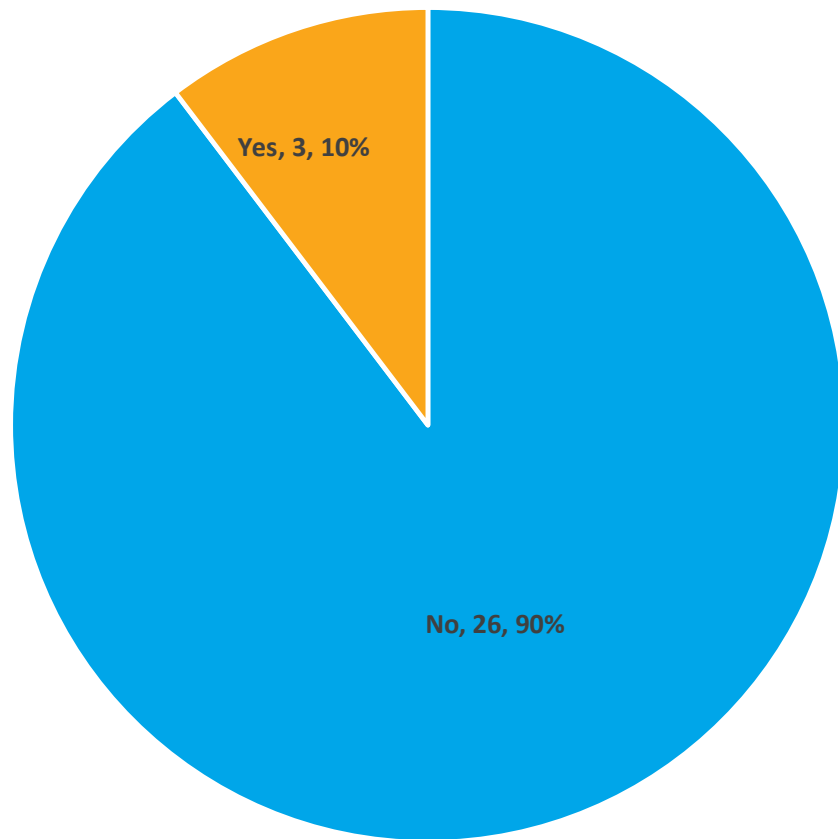

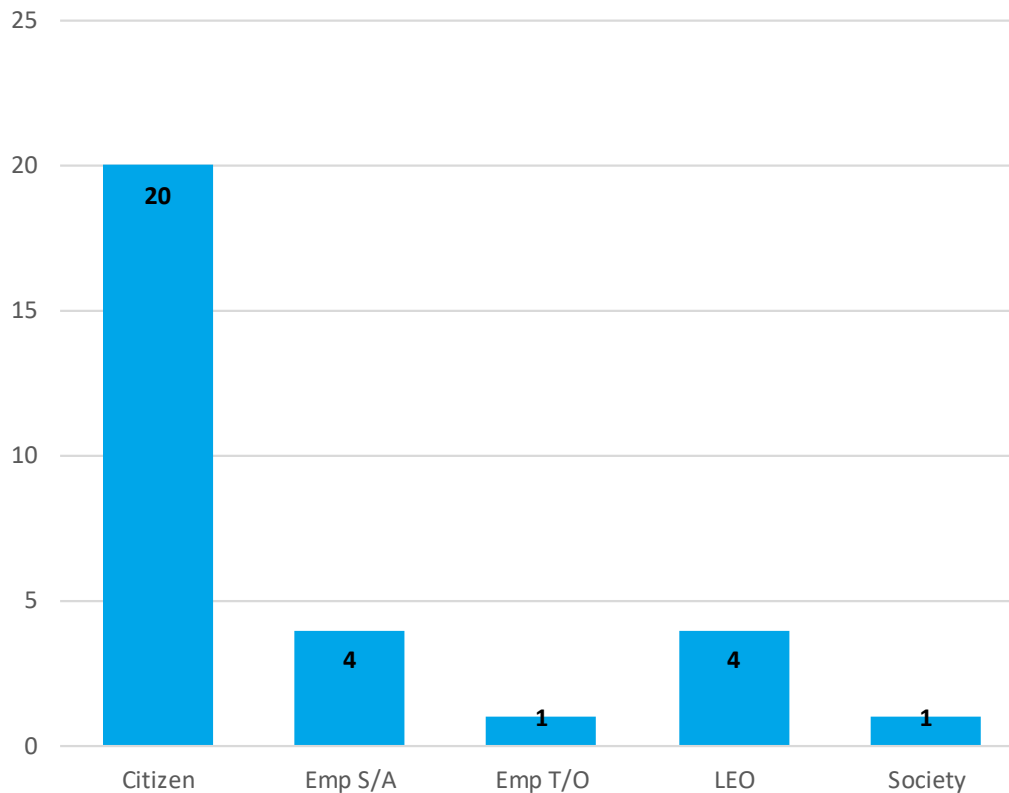

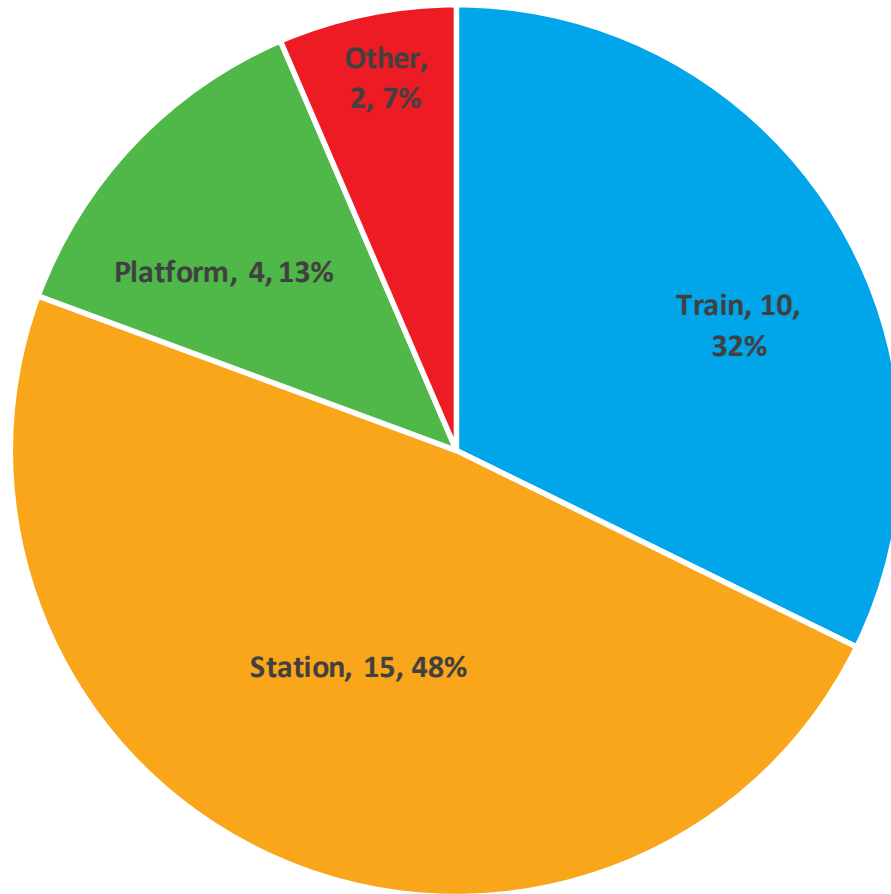

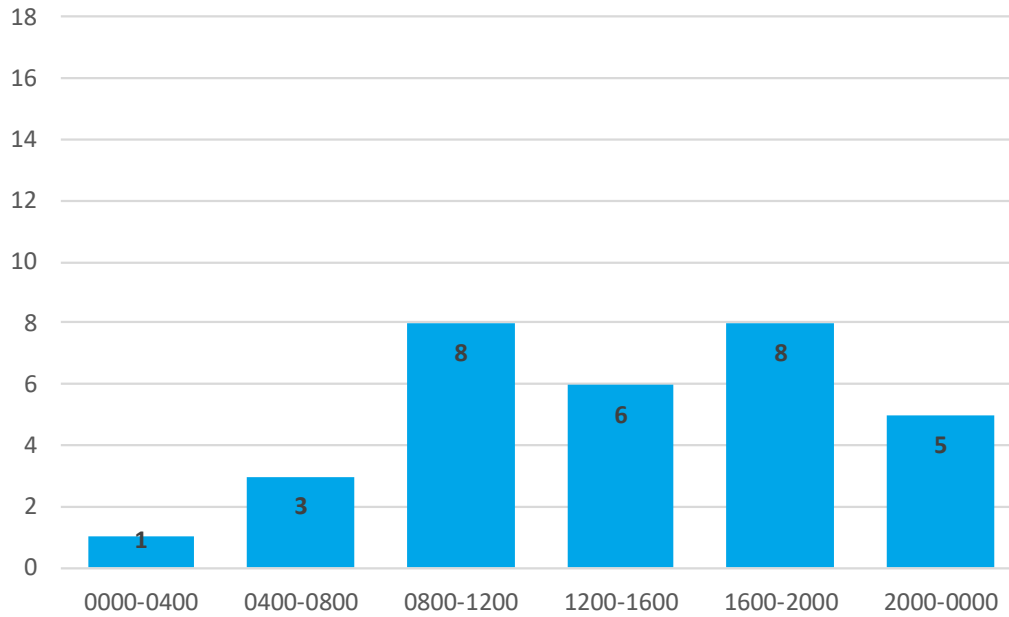


Prohibition Orders by Location
