Perhaps Jeff Lynne was speaking of frustration, and about New York, in the trying times I've mentioned before. I would ride on the legendary and historic transportation system known as the Subway. I lived through the graffiti, broken lights, the crime and nuisance, and skipped fares, I often said to myself, this is really bringing me down. It was draining for me to live day after day in the world class city of my forebears in finding myself constantly brought down. I eventually moved away, but I still enjoy coming back to New York, and seeing my old favorites and discovering new things. And sometimes in places such as Grand Central Terminal, I discover things much bigger than myself.

I ask that you consider your thoughts and words with the goal of building a better BART. I do not wish to feel brought down when I use BART and attend your Meetings. Yet I see and hear much negativity, often from the gallery. I wonder if your policy discussions and ideas might have unintended consequences for people who are different such as myself who might find our reasonable use of the System to be abridged. I ask that you not allow situations and circumstances that cause those of us who are different to be brought down, but to instead remember this basic premise, that BART is The Peoples System.

I write to you again concerning the matter of military equipment used on BART PD. I do not know if I have standing to comment on a matter more than once, given that this is an Ordinance, and that in Public Meetings one gets a single chance to speak on an item, given the need to be fair to all speakers. But I guess I'll write to you about this anyway, and see where it goes.

I ask that you respect Chief Ed Alvarez in his decisions concerning the work of building a safer and better

BART. I feel strongly that any equipment to be purchased and used by BART should be evaluated on its own merits, and not solely by definitions. I am concerned about the substitution of judgement, when Chief Alvarez and the BPD leadership team have greater knowledge of security related matters on BART than really anyone else does.

I can't say if I'm in support or opposed to this proposed Ordinance awaiting your approval. I wish there was a nexus as to how the Public will be helped and affected, but I'm not seeing it. I am concerned that from this an Ordinance could be proposed in the future that could result in Veterans and Service Members finding their reasonable use of BART abridged and denied. I ask that you not allow such negative sentiments to become policy on BART. For I as a Veteran, with disabilities, I am a person just as much, and wishes to use the System just as anyone else normally would.






