Authorization to Appoint (1) New Member and Re-Appoint (4) Sitting Members to Measure RR Bond Oversight Committee

PURPOSE:

To appoint one newly nominated Measure RR Bond Oversight Committee candidate, Janey Qian Wang, Ph.D., to the Committee and reappoint four sitting Committee members to two-year terms beginning July 1, 2023 and ending June 30, 2025.

DISCUSSION:

On June 9, 2016, the BART Board of Directors passed Resolution 5321, which placed Measure RR, a \$3.5 billion BART Safety, Reliability, and Traffic Relief bond on the November 8, 2016 ballot.

Section 11 of the Resolution called for the establishment of a Bond Oversight Committee, which would consist of seven members appointed to two-year terms and eligible to serve for up to six years in total. The resolution specified that members be recruited from the following organizations:

- American Society of Civil Engineers (ASCE 1 member)
- Institute of Electrical and Electronic Engineers (IEEE 1 member)
- American Institute of Certified Public Accountants (AICPA 1 member)
- Association of Budgeting and Financial Management (ABFM 1 member)
- Project Management Institute (PMI 1 member)
- League of Women Voters (LWV 2 members)

On June 30, 2023, three Committee members will become ineligible for reappointment as they will have served six years on the Committee, which is the maximum a member may serve according to Resolution 5321 (Service Limit). The ineligible Committee members were those recruited from ASCE, IEEE and ABFM.

In September 2022, BART staff began recruiting to replace the members who reached their Service Limit. Between December 2022 and January 2023, ASCE put forward one of its members for consideration and IEEE put forward two. In March 2022, staff conducted panel interviews with all three candidates, however, none received a passing score. BART staff members have re-opened the recruitment with ASCE and IEEE. Staff hopes to present two more candidates to the Board to fill the ASCE and IEEE seats before the first meeting of the new term, which is scheduled for September 15, 2023.

In March 2023, BART staff conducted a panel interview with Janey Qian Wang, Ph.D., whom the ABFM recommended for a seat on the Committee. Dr. Wang received a passing score.

Dr. Wang is a BART rider who commutes from Walnut Creek to her job as an associate professor at San Francisco State University. Her research focuses on local fiscal policies, debt administration, and public and non-profit finance. Dr. Wang has consulted for the World Bank in Washington, DC and has either authored, peer-reviewed or presented her work in more than 50 different publications and conferences including a presentation in 2016 called "The Impact of Public Transit Expenditure on City Scaling in China" at the American Society for Public Administration in Seattle, WA. She earned her Ph.D. from Indiana University Bloomington in Public Affairs. She also graduated from the Renmin University of China with a master's in accounting and a bachelor's in economics. Her full resume and application are attached with personal information redacted.

FISCAL IMPACT:

Each of the seven Committee members is eligible for a \$15 per meeting Clipper card reimbursement for transportation expenses. The Committee typically meets once per quarter.

ALTERNATIVES:

The Board could reject some or all of the applicants and direct staff to re-open the application process.

RECOMMENDATION:

Appoint one new member to the Bond Oversight Committee and reappoint four sitting

members eligible for reappointment to the July 1, 2023 to June 30, 2025 term.
