## AB 923 (Wicks)

BART Electricity Procurement and Delivery

- Would amend PUC 708.1 to grant BART broader access to wholesale market resources, including power from the California Independent System Operator (CAISO) market and low-cost carbon-free energy sources.
- The authority to procure electricity from additional sources of supply will enable BART to economically and efficiently meet its long-term electricity needs as well as achieve goals within the Board's adopted Wholesale Electricity Portfolio Policy.
